AWARD LIST FOR THE
2015-2016 ACADEMIC YEAR JEAN MONNET SCHOLARSHIP PROGRAMME

The Jean Monnet Scholarship Programme Evaluation Committee has evaluated the results of the written exam held on 9 May 2015 within the framework of the 2015-2016 academic year Jean Monnet Scholarship Programme and determined the list of candidates eligible for a scholarship.

According to the rules of the Jean Monnet Scholarship Programme, the candidates were supposed to score at least 60 out of 100 from the written exam in order to be entitled for a scholarship. The quotas allocated to each sector indicated in the announcement were filled according to the success ranking.

The names of 210 candidates on the main list and 163 candidates on the reserve list who have successfully passed the written exam are announced in the web pages of the Ministry for EU Affairs (www.ab.gov.tr), the Central Finance and Contracts Unit (www.cfcu.gov.tr), the Delegation of the European Union to Turkey (www.avrupa.info.tr) and the Jean Monnet Scholarship Programme (www.jeanmonnet.org.tr).

MAIN LIST

Information will be provided to 210 people on the Main List via an electronic mail by the Ministry for EU Affairs Jean Monnet Scholarship Programme Office. In this e-mail, detailed information regarding the programme approval process will be given and the forms to be filled by the scholars will be sent. Besides, the scholars will be requested to send their Programme Approval Forms along with **at least two unconditional offer letters** taken from **at least two different EU member countries**, till the deadline specified in that e-mail.

210 candidates who have been found eligible for a scholarship are announced on one single main list according to the success ranking, on the basis of the Important Note-5 on the page 23 of the 2015-2016 academic year Jean Monnet Scholarship Programme Announcement, which was:

'The Ministry for EU Affairs will decide on the placement of the scholars based on the success rankings provided by the Evaluation Committee and considering the aim of achieving a balanced distribution of scholars throughout various EU member countries. Should there be more than 50% of scholars who have selected the same EU member country as their first priority, the scholars with the highest ranking will have the preference on the placement to their first priority whereas the lower ranking scholars who have indicated the same EU member country as first priority will be offered to study

at their successive most appropriate programme alternative, i.e. in another EU member country.¹

Nevertheless, the Ministry for EU Affairs retains the right to give the final decision on the programme approvals to ensure the compliance of the programmes with the fields of study (EU Acquis Chapters) and the optimal exploitation of the scholarships.'

Accordingly;

- The candidates who are among the first 105 (i.e. ranked 1st through 105th) on the main list, have the right to be placed to **their first programme preference in one of the EU member countries**, on the condition that the proposed programme is in line with the EU acquis chapter applied and the general objective of the scholarship.
- The candidates who are among the second 105 (i.e. ranked 106th through 210th) on the main list, will be placed to **one of their programme preferences in one of EU member countries based on the country distribution rules**, and on the condition that the proposed programme is in line with the EU acquis chapter applied and the general objective of the scholarship.
- According to the rules of the Scholarship Programme, the candidates whose first programme preference is considered as ineligible will be placed to their other programme preference found eligible.
- No candidates ranked between 106 and 210, both inclusive, will be replaced with the "first 105 candidates" who withdrew from the scholarship due to any reason (health, family, work etc.).

RESERVE LIST

- Candidates who are not in the main list but scored 60 and above from the written exam are announced in the Reserve List according to the success ranking.
- If a candidate from the main list withdrew from the scholarship due to any reason (health, family, work etc.), the candidate from the reserve list of the relevant sector will be invited according to the ranking.
 - For instance, if a candidate from the university sector standing on the main list withdrew from the scholarship, applicant who is in the highest ranking order in the reserve list of university sector will be invited.
 - In the case where the reserve list of a sector is exhausted or does not exist at all, the applicant who is in the highest ranking order in the overall reserve list will be invited regardless of his/her sector.
- Candidates who moved to the main list from the reserve list will be placed to **one of their programme preferences, based on country distribution rules** and on the condition that the proposed programme is in line with the EU acquis chapter applied and the general objective of the scholarship.

PLACEMENT AND CONTRACTING PROCESS

Placement and contracting process will be conducted in line with the Important Note-6 on page 24 of the 2015-2016 academic year Jean Monnet Scholarship Programme Announcement, which was:

¹ If a scholar has indicated a single EU official language at the time of application and the academic programmes in that EU official language could only be found in a single EU member country, then the scholar has no obligation to submit a second offer letter from another EU member country during the placement process.

'The awardees who are recommended for award of a scholarship on the main list are obliged to submit the documents related to the placement and contracting processes, including the secondment/assignment procedures² within 2 months after the date the awardees are announced or until 29 October 2015, whichever is later. Otherwise, they shall be deemed to be withdrawn from the scholarship.

The awardees who are invited to the main list from the reserve list are obliged to submit the documents related to the placement and contracting processes, including the secondment/assignment procedures³ within 2 months after the date they are first invited and contacted about the placement procedures or until 29 October 2015, whichever is later. Otherwise, they shall be deemed to be withdrawn from the scholarship.'

However, according to the 2012 Financing Agreement from which the financing of the 2015-2016 academic year Jean Monnet Scholarship Programme is provided, all the scholars should complete their programme approval process and sign their contracts till 21 December 2015. Otherwise, they shall be deemed to be withdrawn from the scholarship.

In this context, it is solely the scholars' responsibility to submit the documents required for the programme approval and contracting processes in a timely manner (two months before 21 December 2015 at the latest) so as to sign their contracts.

MAIN LIST ACCORDING TO THE SUCCESS RANKING

RULE 1: The candidates who are ranked between the 1. and 105. on the main list, have the right to be placed to 'their first programme preference in one of EU member countries', on the condition that the proposed programme is in line with the EU acquis chapter applied and the general objective of the scholarship.

RULE 2: The candidates who are ranked between the 106. and 210. on the main list, will be placed to 'one of their programme preferences in one of EU member countries', based on country distribution rules and on the condition that the proposed programme is in line with the EU acquis chapter applied and the general objective of the scholarship.
