IMPORTANT NOTICE: THE ENTRANCE TO THE MIDDLE EAST TECHNICAL UNIVERSITY (METU) FACULTY OF ECONOMICS AND ADMINISTRATIVE SCIENCES B BLOCK (NEW BUILDING) WILL ONLY BE AVAILABLE FROM THE DOOR OPPOSITE TO THE PREPATORY SCHOOL. 2. Applicants need to be present at the exam centre at **09:00 a.m.**
