




FOREST-BASED INDUSTRIES

- Woodworking industry 101.3
- Pulp and paper industry 120.0
- Printing and publishing 134.5
- Total manufacturing 80.3

FOREST-BASED INDUSTRIES SUSTAINABLE FOREST MANAGEMENT

- COST OF WOOD RAW MATERIAL IN EU VERSUS OTHER REGIONS
- EU HAS ONLY ABOUT 5% OF THE GLOBAL FOREST RESOURCES
- PROTECTED AREAS BIODIVERSITY
- WOOD ENERGY DEMAND BIOMASS ACTION PLAN
- RAW MATERIAL EFFICIENCY IN PRODUCTION

STRATEGIC ISSUE RECYCLING OF PAPER

• INDUSTRY COMMITMENT: RECYCLING RATE OF 56% 2005

• POTENTIAL TO INCREASE RECYCLING OF PAPER AND WOOD

STRATEGIC ISSUE ENERGY

- ELECTRICITY PRICES
- MORE IN-HOUSE ELECTRICITY PRODUCTION
- THE USE OF BIOMASS
 - IN PULP & PAPER PRODUCTION $\sim 50 \%$

INFORMATION REQUIRED FOR NEXT BILATERAL MEETING

- ANY LEGISLATION CONCERNING FORESTRY AND ITS INDUSTRIAL SECTORS IN DIFFERENT FIELDS SUCH AS WOOD PROCUREMENT CONDITIONS, MANDATORY STANDARDS, TRADE CONSTRAINS, ETC.
- STUDIES OR POLICY GUIDELINES BY SECTOR ON THE ECONOMIC AND JURIDICAL STRUCTURE OF FORESTRY AND ITS SECTORS.
- MAIN ADDRESSES OF PUBLIC AND PRIVATE INSTITUTIONS OR BODIES RELATED TO DIFFERENT SECTORS SUCH AS MINISTRIES, PRODUCERS ASSOCIATIONS, SECTOR TRADE UNIONS, RESEARCH INSTITUTES, EXPORTERS ASSOCIATIONS, ETC.
- STATISTICAL DATA BY SUB-SECTOR, SUCH AS N° OF COMPANIES BY SIZE, PRODUCTION/TURNOVER, N° OF EMPLOYEES, TRADE, ETC.



- AN OPPORTUNITY TO BE A SUSTAINABLE AND COMPETITIVE SECTOR (ECONOMIC, SOCIAL, ENVIRONMENTAL)
