



## Production of long flax fibres in the EU-25




## **Production of short flax fibres in the EU-25**

Farmer – Single Farm Payment

 Processor – aid per tonne of processed and marketed fibres

# Basic regulations with regard to processing aid

 Council Regulation (EC) n° 1673/2000 of 27 July 2000 on the common organisation of the market in flax and hemp grown for fibre

 Commission Regulation (EC) n° 245/2001 of 5 February 2001 laying down detailed rules concerning the aid

## **Processing aid**

100% aid granted to authorised primary processor on the basis of a sale/purchase contract

Detailed **conditions for an authorisation** of primary processors are listed in article 3 of Regulation245/2001 and specify among others that:

- applications for authorisation shall include a description of undertaking, processing plant, equipment and storage facilities
- > The authorisation is granted after an on-the-spot inspection

### **Processing aid**

- Current level of aid (may be subject to a revision in 2006):
- Long flax fibres:
  - 160 euro/tonne
- **Short flax and hemp fibres:** 
  - 90 euro/tonne
  - Regular notifications from primary processors
  - payment period of 22 months
- condition: **low level of impurities** 7,5% but a possibility to apply derogations:
  - >7,5% 15% for short flax fibre 7,5% 25% for hemp fibre

#### **National Guaranteed Quantities**

Maximum guaranteed quantities divided among the Member States:

- 80 823 tonnes per marketing year of long flax fibres
- 145 296 tonnes per marketing year of short flax and hemp fibres
- Possibility of transfer between the quotas (on a basis of a coefficient)

#### **Additional aid for flax**

- for certain traditionally producing areas of the Netherlands, Belgium and France
- 120 euro/ha (zone I)
- 50 euro/ha (zone II)

### Hemp

 Strict controls ensure the use of hemp varieties with a low THC (tetrahydrocannabinol) content - equal or lower than 0.2%

 All imports of hemp seeds from third countries are subject to the issue of a licence
