- Issues fishing licences and manages fleet registry
- Controls processing establishments
- Carries out studies on site selection, renting and maintenance of fishing ports
- Regulates the wholesale and retail fish markets





DG for Agricultural Production and Development Department of Aquaculture

- > Sets policy for aquaculture
- > Designates aquaculture sites,
- > Regulates rental procedures for sites
- Approves and monitors individual aquaculture investment projects





DG for Agricultural Research Fisheries Section

Conducts research for

- √ fisheries stock assessment
- √ improvement of fishing
- √ technologies
- √ aquaculture
- ✓ processing technology

DG for Organisation and Support




Share of Fisheries in Agricultural GDP at Current Prices, 2004
























Regional Distribution of Marine Fisheries Production (2004)

Fisheries Sector Project

Activities so far done

- Preliminary Draft on Amending the Fisheries Law have been drawn up
- > 50 technical staff were recruitted
- Construction of 30 Fishing Port Offices is underway





Fisheries Sector Project

- ➤ Drafting of implementing regulations on VMS, market standards, fishing licenses, sales notes and logbook and landing declarations is underway.
- Preliminary draft amending fisheries law has been drawn up
