International Agreements: Nuclear

Common clauses in bilateral agreements

Possible cooperation areas:

- a) basic and applied research and development with respect to the peaceful uses of nuclear energy;
- b) scientific and technological research and development, design, construction, commissioning, operation, test and maintenance, decommissioning of nuclear facilities;
- c) utilization of research reactors and particle accelerators;
- d) production and application of radioactive isotopes in industry, agriculture, medicine, and biotechnology;
- e) licensing, nuclear safety, radiation protection, environment protection, radioactive waste management;
- f) nuclear safeguards and physical protection, etc.





International Agreements: Nuclear

Common clauses in bilateral agreements (cont'd)

Cooperation may be undertaken in the following forms:

- a) supply and exchange of nuclear material, material, equipment and facilities;
- b) provision of relevant technological consultancy and services;
- c) exchange and training of scientific and technical personnel;
- d) exchange of scientific and technical information;
- e) transfer of licenses and patent rights;
- f) organization of scientific and technical meetings, and other joint activities;
- g) setting up of joint working groups to carry out specific studies and projects on scientific research and development in the fields of mutual interest;
- h) technology transfer under special agreements between related institutions regarding nuclear facilities; and
- i) other forms of cooperation as may be agreed upon by the Parties.





International Agreements: Nuclear

These Cooperation Agreements

- include also provisions concerning retransfer, safeguards and physical protection of the nuclear material, material and equipment supplied pursuant to agreement;
- to be implemented after the conclusion of implementing arrangements between either Party or authorized persons/entities, which is specifying the terms and conditions of particular cooperative programs and projects, the procedures to be followed, financial agreements and other appropriate matters.





International Agreements: Nuclear

- Bilateral agreements on "early notification of nuclear accidents" concluded with **Bulgaria** (1997) and **Ukraine** (2001).
- Negotiations with Russia and Romania on "co-operation in the peaceful uses of nuclear energy" and on "early notification of nuclear accidents"
- **Ukraine**: "Memorandum of Understanding for Technical Cooperation and Exchange of Information in Nuclear Regulatory Matters" (signed-2005)
