Project Activities

- Logo Competition: A logo competition for the institutional identity of EU Project Coordination Center
 will be organized. Some visibility activities such as establishment of a website and distribution of
 some publicity presents will be also realized.
- Formation of the EU Team: A seminar on "Project Cycle Management (PCM)" and "EU Funds", "IPA
 Instrument and Basic EU" themes will be provided for EU Team. After study visits of project team to
 local authorities, considering gender equality, individual EU Teams including 30 members will be
 established.
- Trainings for the EU Team and EU Project Coordination Center: For the EU Team and the staff of the EU Project Coordination Center "EU Funds", "PCM" and "EU Acquis" trainings will be organized.
- Trainings for Provincial EU Advisory and Steering Committee and NGOs: For the members of the Provincial EU Advisory and Steering Committee and representatives of NGOs a one-day basic EU training will be given by the experts Secretariat General for EU Affairs or BEBKA.
- Trainings in Districts of Bilecik: "PCM", "EU Funds" and "EU Acquis" trainings will be provided to NGOs, Chambers and Public bodies in order to improve their level of understanding and awareness on EU issues. A five day training program will be given by the experts to participants coming from three different districts of Bilecik.
- **Environment Chapter Seminar:** With the participation of certain state institutions which happen to be stakeholders such as Bilecik Province Environment Directorate and Agriculture Directorate a seminar will be organized about Environment Chapter.
- **EU Accession Workshop:** A workshop on "Effects of Turkey's Possible Accession to the EU on Turkey and Bilecik" will be established in association with Bilecik University. Additionally, a project stand will be set at the University.
- Formation of Working Groups: Taking the negotiation chapters into consideration; surveillance-assessment, promotion, communication etc. working groups will be formed under the EU Provincial Advisory and Steering Committee.
