Preface

Introduction to SEI Actions in Practice

Within the framework of the Instrument for Pre-accession Assistance (IPA), the EC and Turkey have agreed on a permanent support facility to strengthen the European integration process. This facility called "Support Activities to Strengthen the European Integration Process" (henceforth SEI) is part of EU's annual financial assistance package to Turkey as of 2002. SEI essentially provides technical assistance for IPA project preparation and capacity building to support the accession process. The SEI has two main components: the "Project Preparation Facility" (henceforth PPF) and the "Unallocated Institution Building Envelope in the Context of the Preparation Process and Accession Negotiations" (henceforth UNIBE). The PPF is a facility mainly focussing on support for the development of project fiches, whilst UNIBE represents a facility primarily aiming at capacity building related to the EU accession process.

With reference to Ministry for European Union Affairs' (MEUA) special role for the qualitative level of various project proposals yearly submitted to the EC, the MEUA has been tasked with the responsibility for implementing the SEI. In this role, the Directorate for Project Implementation (DPI) receives and processes all SEI requests and, after acceptance, gives the green light to the CFCU for the related tendering, contracting and financial implementation (refer

to section 6 for further details). In order to ensure the effective utilisation of SEI funds, the DPI not only approves applications for SEI but also monitors the progress in the implementation of SEI funded actions. During the entire lifetime of each SEI funded action, however, the SEI key beneficiary who applied for the related support is responsible for supervising and, if required, facilitating its implementation.

To support an effective implementation of SEI, MEUA has developed two publications i.e. the SEI Guide and the Guidelines for Developing Specific Terms of Reference. Whilst the SEI Guide explains how potential beneficiaries of SEI can apply for support from SEI, the Guidelines provide a step-by-step guidance for applicant institutions in case they choose to apply for technical assistance provided by the popular framework contract procedure.

This publication, SEI Actions in Practice, supplements the other publications by providing an insight in how SEI works in practice. This is done by telling practice stories of support to the programming process (SEI Action Case 1), technical assistance for tender preparation (SEI Action Case 2), consultancy advice related DIS institution building (SEI Action Case 3), technical assistance for evaluation purposes (SEI Action Case 4), and support to project imple-


mentation (SEI Action Case 5). These stories aims both at general interested reader and can serve as practical examples for ministry staff tasked to prepare applications. In addition, the Compendium tells the statistically interested reader how SEI has been used in the past in terms of a complete statistical overview of all SEI Actions that have been granted under SEI 2002 until SEI 2008 (Annex 1) as well as by providing a breakdown of all granted SEI Actions by type of support.

Overview of the usage of SEI

For a first impression, we provide an overview of how SEI funds have been used until now. The chart below shows that almost 78% of the SEI 2002-2008 funds have been used to provide technical assistance during the various phases of the IPA programme cycle. This included:

- Technical assistance to support for <u>programming</u> (project development, PF drafting, various types of analyses to support the programming process);
- TA to support the <u>tendering</u> (including drafting of tender documents such as ToRs and Technical Specifications, but also support to the evaluation of offers);
- TA to support beneficiaries with the implementation of IPA projects;
- TA to <u>monitor</u> the implementation of IPA projects in support of a project beneficiary or a project steering committee;
- TA to conduct evaluations of projects.

Chart 1: Usage of SEI funds (SEI 2002 - SEI 2008)



Around 17% of the SEI 2002-2008 funds have been used to support **DIS institutions** to fully assume their responsibilities in the context of the decentralised management of IPA funds in Turkey. This included technical assistance to conduct different types of audits, to support the implementation of results oriented monitoring, and training.

The remaining 5% of the SEI funds went to **other support**, particularly support to the set-up of the <u>Translation</u> Coordination Unit of MEUA as well as to small grants to beneficiary institutions for <u>study visits</u> and participation in <u>seminars</u>, <u>conferences</u>, etc.

Background

In order to support the improvement of maritime safety in Turkish waters, the Undersecretariat for Maritime Affairs (UMA) in 2009 felt the need to create a project portfolio for the Turkish maritime administration to be implemented during the period 2010-2013. For this reason, UMA required the involvement of a Technical Assistance Team to develop:

- A Maritime Sector Strategy for accession to the EU and a related Action Plan for the Maritime Sector.
- Prioritise IPA projects in the Maritime Sector,
- Project Identification Sheets and Project Fiches for five priority projects, and
- Procurement documents (terms of reference and/or technical specifications) to support the implementation of the identified priority projects.

The context and implementation of the related SEI action is described below.



Implementation of the SEI action

We focus on the development of the Maritime Sector Strategy and the development of the related IPA project pipeline.

Development of the Maritime Sector Strategy 2010-2015

Promoting safer seas, cleaner seas and coastal areas, secure shipping and maritime transportation, and competitive Shipping Sector in Turkey have been accepted as goals of policies to be achieved in the EU accession process. For this reason, they have also been taken as the four main pillars of Maritime Sector Strategy.

For the development of the Maritime Sector Strategy, the current situation in each policy area was reviewed from the EU ac-

quis perspective by comparing national legislation, international legislation and the EU acquis. This enabled the TA team to identify the gaps between the mentioned relevant legislative texts and to propose institutional strategies and actions to the Maritime Administration for plugging them. Besides the EU acquis perspective, the current situation was also analysed from the International Conventions perspective. In addition to these two legal approximation perspectives, the strategic ap-

proach for each policy area was completed with an institutional capacity perspective i.e. the upgrading of administrative capacity necessary to ensure the practical implementation of the adopted legislation.

In general it was found that the Turkish Maritime Sector has achieved a high alignment level with the related EU acquis. A major activity to be undertaken is the alignment with EU legislation which has just been entered into force under the so-called Erika III Maritime Safety Package. This Package completes the existing measures known as Erika I and Erika II Packages for the prevention of unintentional oil pollution at sea. It focuses on two main aspects: i) stepping up the prevention of accidents and pollution; and ii) ensuring a more effective response to accidents.

Another major legislative problem is that Turkish maritime trade legislation has not been aligned with the related EU acquis. However, Turkey is planning to comply with the



EU maritime trade acquis at the date of accession. The relevant EU acquis to be complied with for Turkey in the accession process has been indicated in the relevant part of Maritime Sector Strategy.

Also in terms of administrative and technical capacity required to implement the aligned national legislation, Turkey has introduced a number of important enhancements since the beginning of EU accession process. Based on the above analytical framework,

however, a number of deficiencies have been identified in each of the four policy areas.

Following the identification of gaps and vulnerable points in the legislation as well as deficiencies in the institutional capacity, strategies to achieve goals and policies have been determined. These are presented within the overarching Maritime Sector Strategy framework for 2010 – 2015 below.

Development of an IPA project pipeline

Based on the Maritime Sector Strategy 2010-2015, the Consultants in close dialogue with UMA, the Turkish Chamber of Shipping and other relevant organizations in the maritime sector developed an Action Plan. The Action Plan identifies the tasks and related schedule for the implementation of the Maritime Sector Strategy as well as the relevant national body (bodies) responsible for the related implementation of each of the detailed strategies. In addition, the Consultants developed a series of project ideas to effectively support the implementation of the identified strategies in line with the Maritime Sector Strategy and the related Action Plan and which would in principle be eligible for support financed by the first IPA component, Transition Assistance and Institution Building.

These project ideas were subsequently presented, elaborated and prioritised in a workshop with the above mentioned key stakeholders. In order to come to a prioritization, all project ideas were subjected to a multi-criteria analysis. The criteria for this analysis were determined by identifying the most relevant factors which affect the implementation of strategies as well as the achievement of the policies laid down in the Maritime Sector Strategy. After ranking the identified factors in terms of their relevance for the implementation of the Maritime Sector Strategy, the top six were selected as key criteria. These key criteria were subsequently scored against each

other to determine their relative weights. This process led to the identification of the following set of key criteria for the multicriteria analysis:

- Impact on the EU accession process
- Compliance with International Conventions
- Safety & Environmental protection issues
- Technical implementation capacity
- Size of investment for implementation
- · Geographical impact of the Project

Based on this and the multi-criteria analysis matrix prepared by the Technical Assistance Team, the following project ideas received the highest score:

- 1. Carriage of Hazardous Cargo at Sea
- 2. Strengthening the administrative capacity for oil spill response in Turkey
- 3. Strengthening of the administrative capacity in the field of marine accident investigation
- 4. Strengthening of the technical capacity for implementation of MARPOL Annex VI
- 5. Strengthening of the technical capacity for training of seafarers

For each of the five priority projects, the Consultants developed a project identification sheet and an IPA Project Fiche. Finally, the short-term experts produced a number of ToRs to support the implementation of the projects either through a contract to be financed by the concerned priority project or through a separate SEI action.

Background

With the increase in urbanisation and the number of cars, especially after 1980s, environmental noise has reached a disturbing level in Turkish cities. The environmental noise problem is most noticeable in the big cities with high population density and complicated and/or concentrated noise sources. The main environmental noise source is road traffic (urban traffic, but also outside the agglomerations). According to official statistics, the total number of all road vehicles in Turkey increased from about 7.8 million in 2004 to nearly 12.0 million by the end of 2007. The total number of passenger cars was 6.5 million at the end of 2007, and has increased to 9.8 million by 2010. It has also to be mentioned that there are almost 2,000 km of major roads with heavy traffic in the country. The noise levels from the public transportation vehicles and lorries are extremely high due to their old age, lack of maintenance and overloading. Taking into account that the noise levels increase with traffic volume and the rate of heavy vehicles, it may easily be seen, that the noise pollution is steadily growing in all Turkish cities. But also aircraft, railway traffic and industrial activity contribute to continuous higher noise levels to which Turkish citizens are exposed.



In the context of Turkey's preparation for accession to the EU, Turkey is adopting the environmental acquis. All legal provisions, regarding environmental noise in the European Union, are covered by the Directive 2002/49/EC relating to the assessment and management of environmental noise Ihereinafter Environmental Noise Directive or END). The aim of the Environmental. Noise Directive is to provide for a common approach to the avoidance, prevention and reduction of the harmful effects of exposure to environmental noise. END aims at harmonising noise indicators and assessment methods for environmental noise. Using these common indicators and assessment methods, it seeks to gather information in the form of "strategic noise maps". This information will be made available to the public and will form the basis for "action plans" at the local level. It is not the intention of the END to set common EU-wide noise limits. The setting of limits remains under the responsibility of Member States.

Turkish National Legislation has been fully harmonized with the FU Environmental Noise Directive. For the purpose of transposition and implementation of the END, the Regulation on the Assessment and Management of Environmental Noise (RA-MEN, or CGDYY) (Official Gazette: 1 July 2005. No. 25862) and its amendment [Official Gazette: 4 June 2010. No. 27601) were published. The next step is to implement the actions mentioned in this Regulation, which particularly focus on strategic noise mapping and action plans. A national Master plan with a strategy on harmonisation and implementation of EU legislation on environmental noise has been prepared in 2008-2009



For the implementation of Directive 2002/49/EC concerning the assessment and management of environmental noise, the Ministry of Environment and Forestry (MoEF) aims to develop and strengthen the institutional capacity in selected municipalities and other institutions which are responsible for the preparation of noise maps and action plan for major noise sources in Turkey. For that purpose, the MoEF developed the Project Fiche "Implementation Capacity for Environmental Noise Directive" which eventually became one of the priority projects of the National Programme 2009 within the framework of IPA I, Transition Assistance and Institution Building.

The Project "Implementation Capacity for Environmental Noise Directive" (henceforth "the Project") contained a service component and a supply component. For the implementation of these two components, MoEF requested and received support from SEI for the drafting of the related tender documentation. The support was provided in the form of technical assistance that was contracted using the relatively quick Framework Contract tendering procedure¹. In essence, the Specific Terms of Reference of the SEI Action required the Consultants

- To prepare ToRs for a service contract for noise mapping,
- To revise the Need Assessment and Market Survey for the Supply Component of the Project, and
- To prepare Technical Specifications for the Supply Component of the Project.

Methodology

Preparation of the Terms of Reference for the service component of the Project was carried out on the basis of:

- a desk study of documents provided by MoEF;
- analysis of responses to questionnaires, prepared by the Consultant and filled in by the Project Beneficiaries, and
- meetings with the representatives of the Beneficiaries.

Counterpart staff of the MoEF organised all the meetings and participated in them. The meetings specifically allowed the Consultants to better understand the present situation with noise management in various Beneficiary organisations, assess data availability and quality, as well as precisely estimate the overall areas, for which the strategic noise maps will have to be prepared during the Project. All information obtained during these meetings was used to prepare the Project outputs, to suggest an implementation schedule for the Project and to develop detailed budget.

On the basis of the findings it can be concluded that, as a rule, larger municipalities as well as institutions within the Ministry of Transport and Communication – Beneficiaries of the project – have most input data necessary for the strategic noise mapping. Moreover, these data are available in electronic form, implying that no excessive efforts need to be invested in their recording and processing nor in their transformation into the noise models.

It was furthermore found that at least part of the staff members of the relevant beneficiary organisations had good understanding of noise mapping and noise management. This will allow the Project to concentrate on strategic noise mapping, activities in pilot areas, training and capacity building, without wasting too much time and resources on basic data collection for huge urban areas.

It was also concluded that although the availability of noise mapping data and overall noise management capacity in other Project Beneficiaries is slightly less than required, the additional efforts for data collection for the activities, which are planned in the identified pilot areas, will not require significant resources.

Development of the ToRs

For the development of the Terms of Reference, the standard PRAG template for the ToRs for fee-based service contracts was used.²

Basing on their findings (see previous section) and assessment of the present situation in Turkey, the Consultants inter alia a workplan and an indicative implementation schedule based on an organisation of the service component of the Project along four activities:

Activity 1: Provision of the noise mapping software to all Project Beneficiaries;

Activity 2: Noise mapping and action planning;

Activity 3: Training, workshops and study tours;

Activity 4: Studies and action planning, aiming at improving the environmental noise

management system in Turkey.

The Consultants also developed the profiles for four key experts including a Team Leader, an Environmental Noise Mapping Expert, an Environmental Noise Management Expert, and a Data Management Expert. Requirements regarding their qualification and skills, general and specific professional experience were fully elaborated in the Terms of Reference.

In addition, the Consultants prepared detailed budgets for situations with two different prevailing pre-conditions, i.e.

- 1. Noise source data are available in pilot areas.
- 2. Noise source data are not available in pilot areas.

Preparation of Technical Specifications

For the preparation of the necessary procurement documents for the Project's supply component, the Consultant had to do the following:

- Revision of document on need assessment and market survey for preparation of strategic noise maps and supply component which will be given after the kick-off meeting as an attachment of the project fiche;
- Assessment of IT equipment in order to identify whether they are complying

- with modelling purposes;
- Preparation of Technical Specifications and revision of Market Survey;
 Selection of appropriate IT Equipment models.

Technical specifications for computer hardware, suitable for the preparation of strategic noise maps, have been identified, basing on the experience of the Consultants and on the minimum requirements of the leading noise mapping software pro-

grammes, available on the European market. Technical characteristics, which are non-essential for the noise mapping, were not specified. Number and composition of hardware kits are based on the Project Fiche and recommendations of the Main Beneficiary – MoEF.

The Consultants have analysed the original document on "Need assessment and market survey for preparation of strategic noise maps and supply component" provided by the

Beneficiary, and discussed it with the Beneficiary. Following this analysis, an updated market research study was prepared, taking into account, that the contents of the supply component were changed since the original document was prepared. The market research study was conducted by the means of on-line search on the internet, specifically focusing on the dealers in the United Kingdom, Turkey, the Netherlands, Germany, and Latvia, and respecting PRAG rules on origin. Only items, customarily available in the commercial marketplace, were considered.

In their Final Report, the Consultants provided a number of recommendations related to the service and supply tender processes as well as the implementation of the Project:

- 1. It is recommended, that during the tender an information meeting or a site visit should be organised for the shortlisted candidates.
- 2. During the inception period of the project the MoEF in cooperation with other Beneficiaries and the successful tenderer should agree on the precise areas, which have to be mapped during the Project: which districts of the greater municipalities should be covered by a complete strategic noise map, and which areas in smaller municipalities should be selected as pilot noise mapping areas.
- 3. It is suggested, that the supply tender is organised in a way, that the IT equipment becomes available to the Beneficiaries within 3 months after the commencement date of the Technical Assistance component. It has also to be noted, that, if the equipment will not still be available after the 8 months after the said date, it might cause delays in the overall Project implementation schedule.

Background

The ARDSI organisation has been set up as an IPARD agency to support the preparation of the implementation of and management of the Community's Rural Development Policy, Common Agricultural Policy and related policies. In the context of the programming period 2007-2013, the development of a Monitoring Management Information System (MMIS) is one of the key priorities for the related IPA component, Rural Development (IPA Component V).

The establishment of an effective MMIS is a pre-condition for the Unit for Project and Control to carry out its monitoring comprehensive tasks in the context of the IPARD programme at the level of programme priorities but also at the measure and project level. This requires an information technology solution that ensures reliable real-time data enabling the direction of the implementation of the IPARD programme towards the Lisbon process.



The MMIS will be based on a database/business intelligent solution. The system should be compatible with and applicable at the level of the Managing Authority at ARDSI Head-quarters as well at the level of the Provincial Coordination Unit. The MMIS system in other words should integrate data collection, processing and analysis in such a way that it allows key stakeholders to support the preparation of evaluation reports, to continuously enhance the programme's efficiency, effectiveness, impact and sustainability, and to design future strategies of the IPARD Programme for the different hierarchical levels.

Implementation of the SEI Action

In order to develop an MMIS in line with the requirements are outlined above, the Consultants implemented the following main activities:

- Conduct an analysis of the current situation and carry out a gap analysis
- Conceptualise an appropriate MMIS and identify the related BI solutions, and after acceptance
- Prepare the related Technical Specifications and Tender Dossier for a system to be installed at the ARDSI and linked initially to branch offices and the Managing Authority at the Ministry of Agriculture.

Each activity is briefly described below.

Situation analysis

In order to scope the appropriate software and other IT requirements, as well as to prepare the related tender documentation, the Consultant started with the analysis of the IPA Operational Programme and the present monitoring system at ARDSI.

At the time of the assignment, the ARDSI had been recently accredited at the national level by the National Authorizing Officer at the Undersecretariat of Treasury. It subsequently went in the conferral of management auditing phase by the European

Commission, for which it officially applied through the Competent Accrediting Officer.

The current ARDSI IT System evolved historically over the short lifetime of the Institute as a set of IT systems, databases and tools developed to bring the Institute to an operational level in the priority sectors during the accreditation process in a relatively short period. The procedures and information flow for the data collection system are defined in detail and adequately described in documents, and could thus serve as a





source of information for the design of the IT based system. Although the IT hardware and software were to a certain degree adapted to establish a monitoring system, the existing IT as well as the IT application at the ARDSI were found to be in essence silo-based i.e. preoccupied with IT functionality and mainly looking at solving specific short-term administrative issues rather than working in a coordinated manner towards long-term strategic goals.

It was therefore concluded that although this initial set-up certainly covered the needs of the individual departments of the ARDSI, the existing ARDSI IT system was oriented to support the paper-based monitoring without adequate system integration across the organisation.

MMIS concept

In order to support the ARDSI effectively to fulfil its role as Operating Structure, the present silo-based monitoring system should evolve towards a more enterprisewide integrated system. This will establish a single version of the truth of the monitoring information, enabling the management of the IPARD Programme in real time and in different geographic areas.

In the light of the findings during the initial phase of the SEI assignment, the recommended concept for the ARDSI IT based data collection system builds on the development of a Monitoring Management

Information System (MMIS) for the IPARD programme that will


- unify the functions of the systems, databases and tools that are currently in operation and in line with the procedures and information flow in place with regard to monitoring activities, and
- extend these functions to meet the requirements set out in these procedures as well as integrate with them other relevant systems (such as the Accounting and the Human Resources System) to provide a fully automated and integrated working environment.



How to develop a Modern Integrated Monitoring System?

The present proposed Monitoring Management Information System (MMIS) at ARDSI continues to be the foundation for evolving in the future towards a more strategically enterprise-wide system. The IPARD Managing Authority as well as the other national and EU operational programme authorities should be involved in such a process.

The process for developing the recommended IPARD Monitoring system at ARDSI is illustrated in the picture below.



The process of developing the strategy (step 1) until the plan of operation (step 4) and their links will be carried out through an integrated monitoring system (step 5). The process cycle described in the picture was recommended to be applied at the level of the IPARD programme as well as at the level of ARDSI as an organisation.

Preparation and submission of draft technical specifications and tender dossier for "IT-based Data Collection System"

The definition of the IT-based data collection system standards as well as the definition of the related technical and functional requirements followed the ARDSI process as de-

scribed in the ARDSI Manual³ and the Situation Analysis carried out by the TA team. The following table summarizes the components of the MMIS for the technical specification to be incorporated into the tender dossier:

Background

TÜRKİYE İSTATİSTİK KURUMU

In the context of the pre-accession process, Turkey is upgrading its statistical system according to EU standards on the methodology and quality of compiling and processing statistical information and to ensure the efficient coordination by the Turkish Statistical Institute(TSI). To realise this upgrading, the EU and Turkey agreed on a multi-phase project developed by the key stakeholders in this field. The first phase of this project primarily focused on the collection, processing and dissemination of sectoral data as well as the renovation of the IT system of the TSI. The second phase mainly involved capacity building of institutions responsible for sectoral statistical systems and harmonisation of data collection and processing.

The Upgrading Statistical System of Turkey Phase II (USST II) Programme consisted of 12 substantive projects. In addition there were two support projects. Some of the projects were

divided into sub-projects. In total there were about 50 programme elements. The 'architecture' of USST II meant that services were provided under a Service Contract, two Framework Contracts and a Direct Grant for Training Agreement. The modes of delivery of services were 292 consultancy missions (in total well over 3000 work days by Short Term Experts) and 199 training activities, including study visits; a total of 491 activity elements. In addition, nearly 1000 work days by Long Term Experts were spent on managing the Programme; this does not include TurkStat staff involved in programme management.

The principal objective of the SEI assignment was the evaluation of the USST II Programme in terms of the achievement of its objectives. The services to be provided by the Consultant included reviewing documents and interviewing TurkStat Units and data provider organizations in order to evaluate the relevance, effectiveness, efficiency, impact, and sustainability of USST II. The evaluation should also result in recommendations for the technical assistance component of the next stage of Upgrading Statistical System of Turkey, USST III.



Implementation of the SEI action


Of the many documents relating to USST II, including programme descriptions, progress reports, mission reports of Consultants and reports by TurkStat staff members and others about their participation in activities, as well as financial and other administrative reports, the Consultant has reviewed a few hundred.

In addition, the Consultant has held 20 group interviews, involving about one hundred people in total, of which about 85 TurkStat staff members. The size of the interviewed groups was 2-16. The Consultant re-interviewed several individual staff members to obtain clarifications about what was said during the group interviews.

On the basis of the collected information described above, and for each of the 12 projects (as well as most sub-projects), the Consultant prepared an evaluation matrix, representing scores on the five evaluation dimensions mentioned above, using a 5-point scale (very high=5; high=4; moderate=3; low=2 and very low=1). The average score across all programme elements is 4.2.

General observations of the Consultant

The assignment was not to assess (parts of) TurkStat, but to assess the achievements of USST II. This means that any critical remarks do not relate to the overall performance



The consultancy missions of USST II were very well received by TurkStat staff. The appreciation was indicated through the customary TurkStat reporting system. The average score was 9.2 on a scale from 1 to 10.

Often, a symbiotic combination of international and national experts was used. The role of the international

experts was usually introducing EU legislation and agreed European methodological practices, and in some cases assisting in applying the methodology. Turkish experts primar-

ily 'translated' methodology into practical solutions for Turkey. Other Turkish experts worked on software applications.

Some training activities were administrative in nature and some had the character of a meeting rather than training.

Study visits to EU countries were also much appreciated, although a minority of Turk-Stat staff felt that study visits were most

useful if the lessons learned could be directly applied to the Turkish situation.

A large number of TurkStat staff members (around 600) have participated in either training or study visits. This has had positive effects on the collective ownership of the modernization processes, which was clearly noticeable during the interviews. More generally speaking, the Consultant found that the corporate spirit' within TurkStat is very good.

Overall conclusions and recommendations of the Consultant

The implementation of the various service contracts in the framework of USST II and the related results have each contributed to the success of the USST II programme. The Service Contract for Technical Assistance provided the largest contribution to USST II by far. Overall, the Contract was well implemented and very successful. Also the Direct Grant Agreement for Training contributed very significantly to the success of USST II. The Framework Contract on Improvement of Hospital and Health Expenditure Statistics provided support was well executed and produced valuable results. Also the Framework Contract on Improving of Cause of Death Statistics provided support to sub-project 5.7.5. was successful. Two contracts anticipated under the USST II were cancelled4.

Because the Acquis in the area of official statistics is broad and complex, it is clear that it would take considerable time and effort for Turkey to achieve compliance with the Acquis. That is why the EU has been applying various support instruments, over an extended period of time. Turkey has participated in several Multi-Beneficiary Programmes for Statistics, USST however is exclusively directed toward Turkey. It has been conceived to be executed in 3 successive phases: USST I, USST II and USST III. The successive phases of USST are designed as a stepwise sequence of actions to address issues of compliance with the Acquis, For those topics where compliance with the Acquis has not been fully achieved. USST III must provide the final steps.

⁴ These concern a Service Contract for Data Collection which was planned to provide the necessary services for the implementation of pilot surveys, and a Supply Contract for hardware, software and office equipment.

The capabilities of TurkStat to implement support programmes were found to be excellent, not only in terms of statistical expertise and willingness to improve, but also in terms of project management.

Generally, the Consultant endorses what is set out in the draft USST III fiche that was provided to him. However, the Consultant thinks that in some additional areas which are not foreseen by USST III further assistance would also be beneficial.

For instance, in addition to having a single visibility event at the conclusion of USST III (similar to what was done for USST II), the Consultant recommends to generate a more continuous visibility through the website of TurkStat and by holding a press conference when landmark results have been achieved, or when important new (pilot) surveys are launched.

Across all statistical domains, TurkStat seems to be well under way to comply with EU standards. In agriculture, for instance, which is a domain for which EU requirements are strict and detailed, the Consultant's impression is that much progress has been made in recent years. However, in other areas (e.g. national accounts) there are still technical difficulties, partly because there is a lack of high quality basic statistical data with the required level of detail and/or frequency, but also because of a lack of useful administrative data sources.

The Consultant recommends that under USST III technical assistance be focused on a number of selected domains i.e.

- Business register
- Business demography
- Business statistics (improvement of timeliness and detail)
- Population and Demographic Statistics (vital statistics
- Migration and asylum
- Analysis of the census
- Labour Force Survey
- Labour Cost Index
- ESPROSS analysis
- Information society statistics
- Economic Accounts for Agriculture
- Health Accounts
- Annual Economic Accounts
- Quarterly Economic Accounts
- Regional accounts
- Prices (producer prices)
- Energy (energy balances)
- Administrative capacity building
- Quality management systems
- ICT Systems

Background

Corporate governance consists of a set of processes, customs, policies, laws and institutions affecting the way people direct administer or control a corporation. Corporate governance also includes the relationships amongst the players involved (the stakeholders) and the corporate goals. The principal players include the shareholders, the management and the board of directors. Other stakeholders are employees, suppliers, customers, banks and others like lenders, regulators, the environment and the community at large.

IT governance is a subset discipline of corporate governance, focused on IT systems

and their performance and the way IT risks are managed. The discipline of IT governance deals primarily with the connection between strategic objectives and IT management of an organization. It highlights the importance of IT related matters in contemporary organizations and requires that strategic IT decisions are owned by the corporate board, rather than by the chief information officer or other IT managers.

The primary goals for IT governance are to

- 1. Assure that the investments in IT generate business value;
- 2. Mitigate the risks that are associated with IT.



This can be done by implementing an organizational structure with well-defined roles for the responsibility of information, business processes, applications, infrastructure, etc. Accountability is the key concern of IT governance.

The Capital Markets Board (CMB) is the regulatory and supervisory authority for the investment services and securities markets in Turkey. CMB supervises various players on the capital market such as publicly held listed companies, intermediary institutions, exchanges, etc. in order to ensure secure, fair and orderly functioning of the market and to protect investors. CMB plans to govern and audit the information systems of these players on the capital market.

Within this context, the main objective of this SEI action was to develop appropriate regulations for the governance of IT systems and regulations for the audit of these systems, thereby paying attention to the existing legislation and regulations in Turkey and best practices across the globe.

Implementation of the SEI action

At the start of the project, a project kick-off meeting was organized at the premises of the CMB. The meeting was attended by representatives from the CMB EU Affairs Group, the CMB IT Department, the CMB Accounting Standards Department, the EU Delegation, the CFCU and the TA experts. At the kick-off meeting, the main objectives and deliverables of the project were reemphasized.

While implementing the assignment, the TA team worked very closely with a CMB group consisting of six CMB staff members. In addition, the EU Affairs Group of the CMB provided effective coordination to help ensure an efficient implementation of the activities planned by the TA team.

In project meetings, in addition to CMB project staff, representatives from related CMB departments also participated in accordance with the agenda of the relevant meeting. The CMB project group members also provided regular input or feedback via email. Draft documents such as draft regulations and reports were exposed to the CMB project team who in turn shared the documents with their colleagues in the relevant CMB su-

pervisory departments

Furthermore, a questionnaire that was sent to intermediary institutions during the project implementation was prepared with the contributions of a representative from the Intermediary Activities Department of the CMB

At the end of the assignment, a closing meeting was organized at the premises of the CMB. The meeting was attended by representatives from the CMB Management, the CMB EU Affairs Group, the CMB IT Department, the CFCU and the experts from the BBA. The experts from BBA presented their final report.



Study of relevant legislation and regulations in Turkey

During a desk study phase, all relevant legislation and regulation from the following Turkish institutions were identified, collected and analysed:

- Capital Markets Board of Turkey
- Central Registry Agency
- ISE Settlement and Custody Bank
- İstanbul Stock Exchange
- Turkish Derivatives Exchange
- Association of Capital Market Intermediary Institutions of Turkey
- Banking Regulation and Supervision Agency
- The Banks Association of Turkey
- Internal Audit Coordination Board



Exploration of best practices with global financial market authorities

The most relevant global financial market authorities were explored by assessing the available information on their website and by obtaining information from privileged personal contacts with experienced internal audit and compliance practitioners around the globe [USA, Germany, United Kingdom, Japan, Netherlands].



The following global institutions were explored:

- Europe: The European Commission (EC)
- The Netherlands: Autoriteit Financiële Markten (AFM)
- Germany: Bundesanstalt für Finanzdienstleistungsaufsicht (BaFin)
- Belgium: Committee for System Risks and System relevant Financial Institutions (CSRSFI) and Banking, Finance and Insurance Commission (CBFA)
- United Kingdom: Financial Services Authority (FSA)
- Japan: Financial Services Agency (FSA)
- Malaysia: Securities Commission (SC)
- USA: Securities and Exchange Commission (SEC)
- International: International Organization of Securities Commissions (IOS-CO)

The exploration of global practices leads to the conclusion that no single regulator around the world has gone, as CMB intends to do, in the direction of developing regulations with regard to IT governance.

The situation is different with regard to IT audit. IT audit has matured over the years and has evolved from an approach which was limited to a review of automated financial controls only to a review of information security. Information security (covering access security up to business continuity) and data privacy are items that many IT auditors around the world will look at based on their own professional standards, but not based on a review of compliance with a regulation on IT governance.

Visit to AFM in the Netherlands



The financial markets authority in the Netherlands (AFM) is known to CMB because of a project in the past. On request of some staff members of CMB, the Consultant got in contact with AFM and visited them in Amsterdam.

Although AFM does not regulate IT governance in the way CMB intends to, this visit led to a number of useful notions:

- In all supervised institutions there shall be a clear distinction between those who develop the strategy and those who run the organization. It emphasizes the agency relationship between board of directors and senior management;
- AFM compares the actual 'behaviour' of institutions with the expected behaviour. Expected is not limited to compliance with regulations only;
- The prudential supervision is organized by the Dutch central bank (De Nederlandse Bank). AFM and the central bank apply the twin peaks model;
- AFM does not regulate IT governance, but considers IT governance part of integer and
 controlled management. AFM does not look at single IT components but at the entire
 business process. Sound and common sense governance and control principles (due
 care) are expected to be in place without regulating them;

- AFM's supervisory approach is principle-based. AFM focuses a lot on guidance. When an institution does not appear to do the right thing, AFM will first guide them on how to improve;
- AFM's approach is by design also applicable on external service providers in case activities or entire business processes are outsourced.

IT governance regulation

The most relevant internationally accepted methodologies were assessed in detail with regard to their possible application to the institutions regulated by CMB. The Consultants started from the CobIT approach⁵ and realized that there were many control objectives that were probably difficult to apply in a Turkish context and in smaller institutions. The TA discussed with the project team which control objectives to maintain. They also developed a survey for the smaller intermediary institutions in order to get a better understanding of their modus operandi with regard to IT.

Following the analysis of the survey results and the analysis of the relevant accepted international approaches, it was also concluded with the CMB project team, that there was no immediate need to have different regulations for different categories and sizes of supervised institutions. The TA subsequently developed a complete set of IT governance regulations that is a blend of globally accepted frameworks, good management principles, local culture and common sense.

IT audit regulation

The TA developed a complete draft of the IT audit regulations. It is important to note that the audit regulations have not been developed in a prescriptive way, in order to allow the auditor to apply his own professional approach and practices. Specifically in the case of smaller institutions, it

will be up to the auditor to assess whether the conditions in place are sufficient to meet the business control objective. For a limited number of regulations an adapted approach has been identified in the case of smaller institutions.

⁵ COBIT (Control Objectives for Information and related Technologies) is a methodology for evaluating a organisation's IT department.

Suggestions with regard to the audit approach

One of the remaining questions is "who is going to perform the audit". The TA advised CMB to use independent audit firms to perform this job. The audit of the IT environment should preferably be done by the same firm who performs the financial audit, as serious weaknesses in the IT governance of an institution may also have an impact on the 'going concern' principle.

The independent audit firms, although licensed by CMB, require additional qualification to perform IT related audits. A qualification in IT related audits implies that the leading auditor (the auditor who leads the engagement and signs the report) is properly certified and has executed similar engagements for the last five years. It was proposed that audit firms may decide to subcontract the IT audit engagement, but only to individuals with the necessary qualifications and expertise which are explained in the previous paragraph.

The TA advised that relevant consulting firms should not be allowed to perform the IT audit of CMB supervised institutions, but instead can be helpful in supporting these institutions to comply with the IT governance regulations and to be prepared for a true IT audit.

For small institutions a more pragmatic approach could be considered, whereby the institution would establish a self-assessment process and have this process validated by their independent auditor. Of course, CMB will always retain the right to undertake its own audits. These audits should be led by the respective supervisory departments, but they will use qualified IT auditors to audit the IT governance components. The qualifications will ideally be in line with what is expected from the independent audit firms when performing IT related audits. This approach will assure an integrated supervision.
