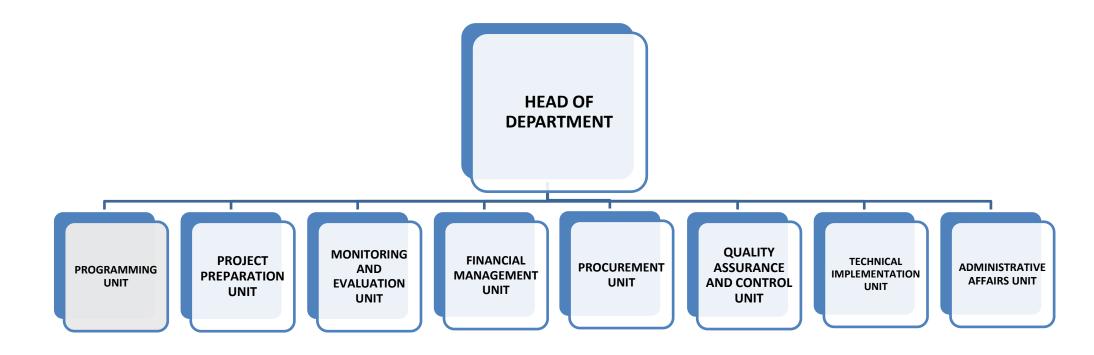

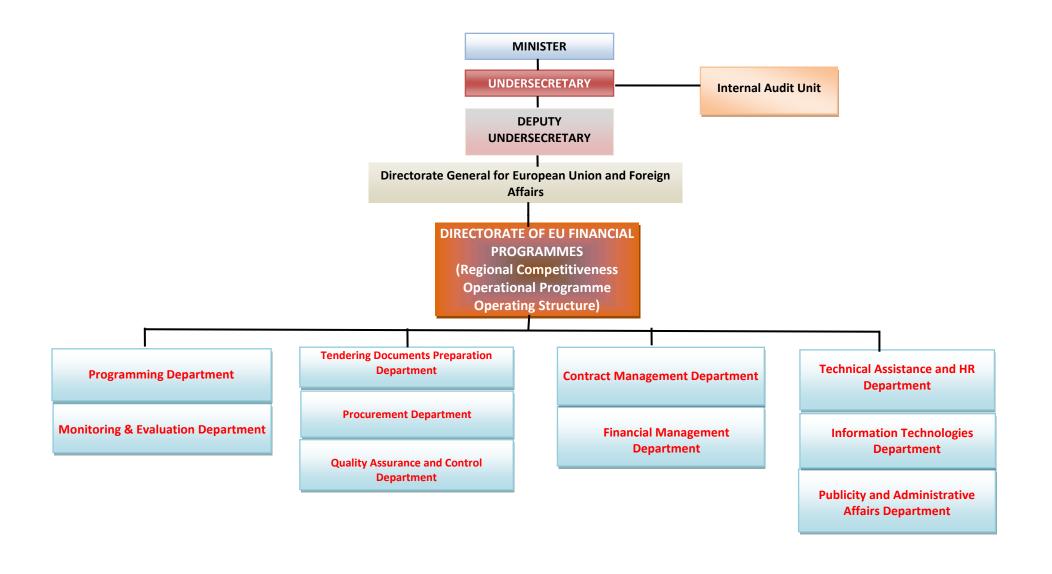

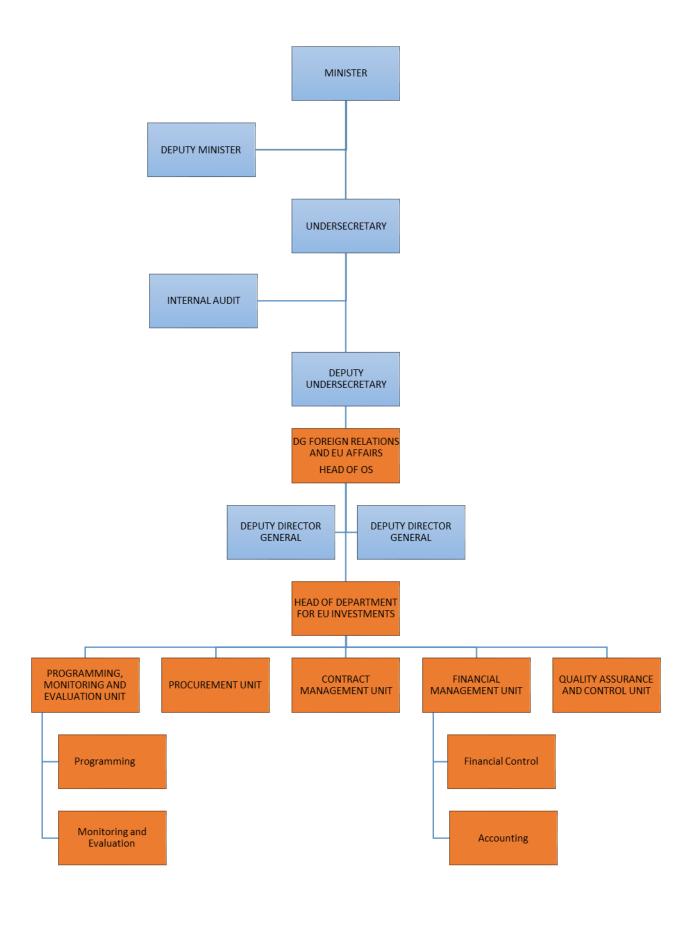

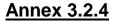
THE ORGANIGRAMME OF THE DIRECTORATE OF EU FINANCIAL PROGRAMMES



THE ORGANIGRAMME OF MINISTRY OF TRANSPORT, MARITIME AFFAIRS AND COMMUNICATIONS

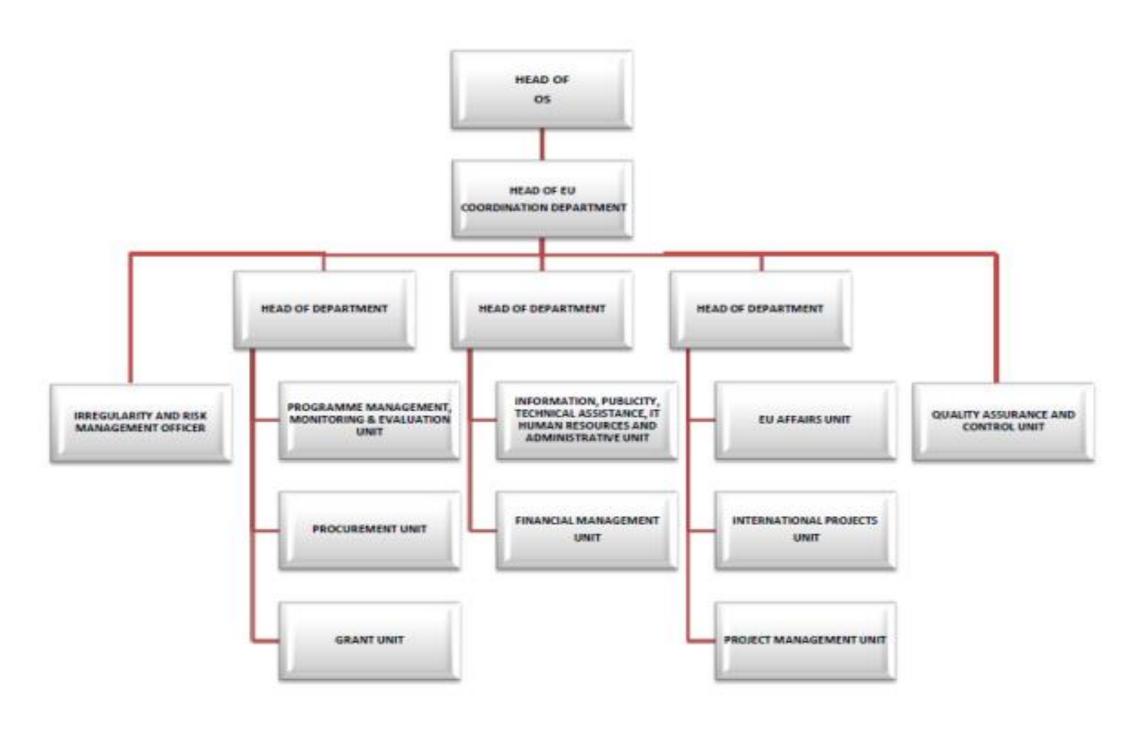
Operating Structure



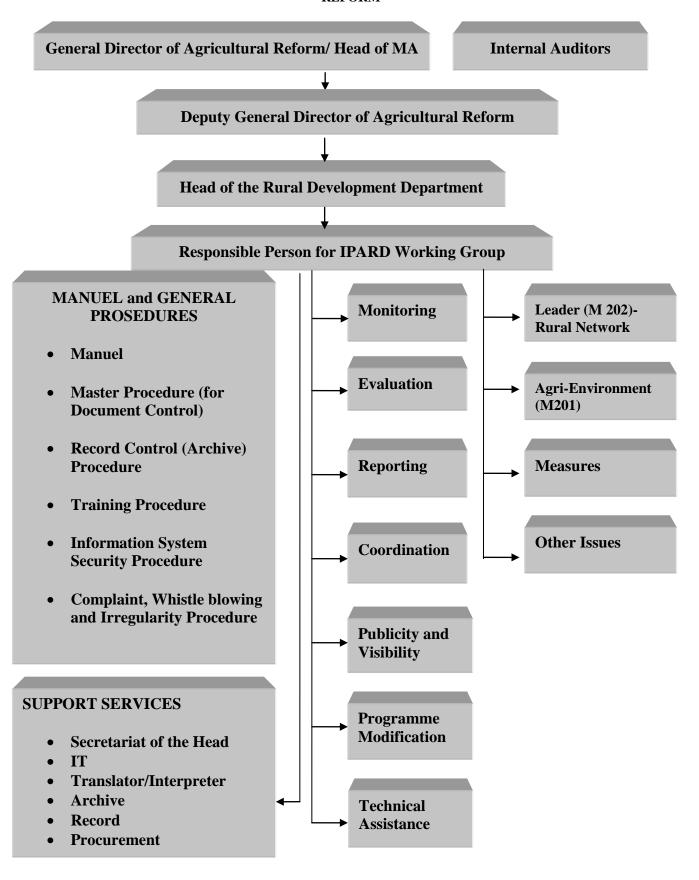


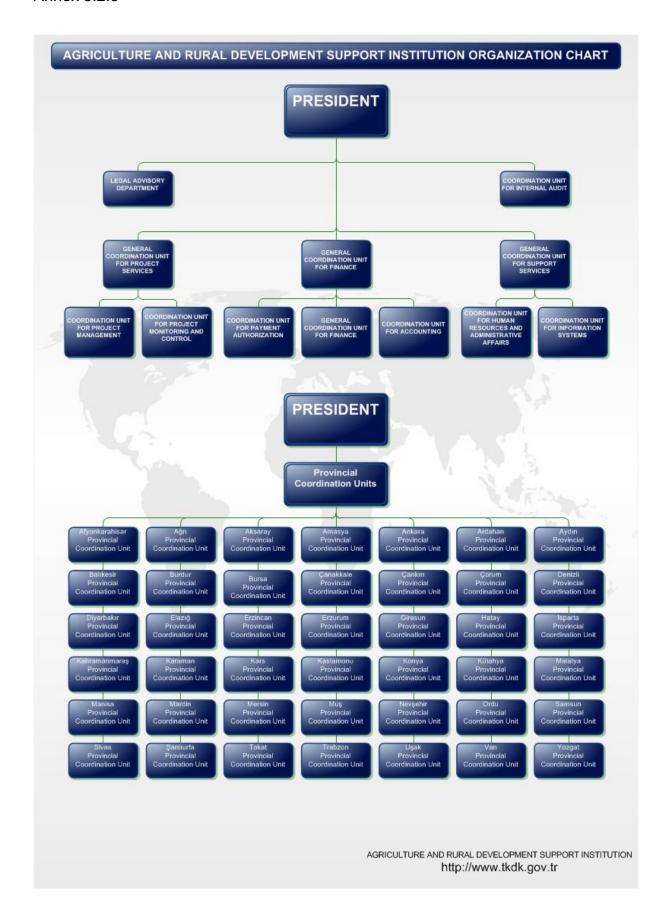
