## LEGAL BASIS - I

### RELATED EU LEGISLATION:

DIRECTIVE 2000/9/EC OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL OF 20 MARCH 2000 RELATING TO CABLEWAY INSTALLATIONS DESIGNED TO CARRY PERSONS.



## LEGAL BASIS - II

### TRANSPOSING REGULATION:

THE REGULATION ON CABLEWAY INSTALLATIONS DESIGNED TO CARRY PERSONS HAS BEEN TRANSPOSED BASED ON DIRECTIVE 2000/9/EC AND PUBLISHED IN THE OG NO. 25705, DATED 19 JANUARY 2005.

THE REGULATION ENTERED INTO FORCE ON 19 JULY 2005.

MANDATORY IMPLEMENTATION WILL BEGIN ON 19 JULY 2009.



## EXCHANGE OF OPINION WITH THE EUROPEAN COMMISSION

THE TRANSPOSED REGULATION WAS SENT TO THE EUROPEAN COMMISSION IN FEBRUARY 2006.

- THE LAW NO. 4703 ON THE PREPARATION AND IMPLEMENTATION OF TECHNICAL LEGISLATION ON PRODUCTS (PUBLISHED IN THE OG. NO 24459 DATED, 11.7.2001),
- THE REGULATION NO. 2001/3529 ON MARKET SURVEILLANCE OF PRODUCTS (PUBLISHED IN THE OG. NO. 24643, DATED 17.1.2002),
- THE REGULATION ON PROCEDURES AND PRINCIPLES FOR MARKET SURVEILLANCE TO BE PERFORMED BY THE MIT (PUBLISHED IN THE OG. NO. 25103, DATED 9.5.2003).
