## **EU LEGISLATION**

# **TURKISH LEGISLATION TRANSPOSING THE CPD - I**

- Regulation on Construction Products (89/106/EEC)" was published in the Official Gazette dated 08.09.2002 and No.24870 and entered into force on 08.06.2004
- The Regulation has been amended three times to extend the transition period.
- The transposed legislation has been sent to the European Commission and the response of the European Commission is now expected.

## **RESPONSIBLE AUTHORITY**

- The main responsibility of the adoption and implementation of the Community acquis in the field of Construction Products lies with the Ministry of Public Works and Settlement.
- Due to its mandate and responsibilities, the Ministry is the key actor for market surveillance of construction products.





## **IMPLEMENTATION**

 The Regulation on Construction Products is in force since 08.06.2004 with a transitional period.

 During the transition period, the producer is free to conform either to the previous legislation and standards or to the Regulation on Construction Products and the harmonized standards.





### CURRENT STATE OF THE STANDARDS WITHIN THE SCOPE OF CONSTRUCTION PRODUCTS DIRECTIVE

There are 252 Harmonized European standards referred in the Construction Products Directive. 192 out of the 252 hENs have been adopted by TSE. Remaining 60 hENs are in the work plan of TSE to be transposed.

## **MARKET SURVEILLANCE - I**

#### **LEGAL BASIS:**

- Market surveillance is carried out pursuant to the provisions of;
  - The Law No. 4703 on the Preparation and Implementation of the Technical Legislation on Products
  - Regulation No. 2001/3529 on the Market Surveillance of Products, published in OG. No. 24643, dated 17.1.2002
  - Regulation on Construction Products
  - Communiqué on the Principles and Methods for Market Surveillance of Construction Products- published in the OG No. 25501, dated 23.06.2004.





## **MARKET SURVEILLANCE – II**

#### **ADMINISTRATIVE STRUCTURE:**

- "Construction Products Market Surveillance Inspector Groups" have been constituted within the structure of Public Works and Settlement Provincial Directorates under the governorships of the provinces. These inspector groups will be in charge of market surveillance of the construction products.
- Preliminary training has been delivered to these groups. By this means 373 inspectors have been assigned in 81 Provinces.





## MARKET SURVEILLANCE ACTIVITIES

- After the transition period, ex-officio surveillance will take place. For the system to be operational, institution building efforts are being carried out. These are:
  - Determination of the infrastructure and basic facilities of the existing laboratories.
  - Improvement of test facilities (EU projects are still at tendering stage).
  - A twinning project funded by the EU. UK's ODPM has been selected as the partner. A twinning contract is to be signed for the start of the project.
