IMPORTANCE ATTACHED

- Turkey attaches great importance to the return of cultural objects unlawfully removed from their territory.
- Turkey, as the EU, has as a fundamental aim the protection of national treasures having artistic, historic or archaeological value and the prevention of them from unlawful remove.





EU DIRECTIVES

COUNCIL DIRECTIVE 93/7/ECC of 15 March 1993 on the return of cultural objects unlawfully removed from the territory of a Member State, (OJ L 74, 27.3.1993, p. 74)

NATIONAL LEGISLATION

• THE CONSTITUTION OF THE REPUBLIC OF TURKEY

stated in Article 63:

"The state shall ensure the conservation of the historical, cultural and natural assets and wealth, and shall take supportive and promotive measures towards that end"

LAW NO. 2863 ON THE PROTECTION OF CULTURAL AND NATURAL HERITAGE

OG No. 18113, dated 7.7.1983

(Amended by Law No. 3386, dated: 6.16.1987) (Amended by Law No. 5226, dated: 7.14.2004)





NATIONAL TREASURES

<u>Law No. 2863</u>, <u>Article 24</u> stated that National Cultural Treasures shall be reserved in the museums and evaluated by the State.





PROHIBITION ON TAKING THE PROPERTIES OUT OF TURKEY

<u>Law No 2863</u>, <u>Article 32</u> stated that movable cultural property that has to be preserved inside the country cannot be taken out of the borders.

However, taking into consideration national benefit, such property can be temporarily sent outside the country for exhibitions on condition that all security measures are taken.

PROCEDURES FOR REMOVAL AND RETURN OF CULTURAL GOODS

- The Ministry of Culture and Tourism is the main government body responsible for the regulation of procedures of temporal removal of movable cultural goods from Turkey.
- These procedures are listed in the "The Regulation on the Exporting and Importing of Movable Cultural and Natural Property to be preserved" (OG No. 18314, dated 2.16.1984)





CATEGORIES OF CULTURAL GOODS

- The definition of Cultural Property is made in the Article 3 whereas the definition of movable cultural property is in the Article 23 of Law No. 2863.
- Article 23 explains which cultural property has to be protected.
- Categories of cultural goods is required to be redefined as listed in the Annex of Directive 93/7.





EXCHANGE OF OPINION WITH THE EUROPEAN COMMISSION

- A copy of the preliminary draft text transposing Council Directive No. 93/7/EEC was sent to the European Commission for comments.
- Technical studies on preperation of draft legislation are continuing regarding the above mentioned Directive and also the Council Regulation No. 3911/92/EEC.
