Objectives

facilitate access to healthcare and the reimbursement of the costs during a temporary stay abroad by simplifying the procedures

Legal context

– **Article 42 EC Treaty**

– **Regulation No 1408/71**

Article 22 of Regulation 1408/71

- ***persons insured under the statutory sickness insurance scheme of a Member State***
- ***temporary stay in another Member State for personal or professional reasons***
- ***entitlement to health care***
- ***according to the legislation of the Member State of stay***
- ***competent Member State is responsible for the costs***

History

- ***Action Plan on Skills and Mobility (February 2002)***
- ***Conclusions of the European Council of Barcelona (March 2002)***

Commission's approach

- ***Communication of 17 February 2003 concerning the introduction of the European Health Insurance Card***
- ***method and timetable for the introduction of the EHIC***
- ***flexible and progressive approach***
- ***introduction of the EHIC in three stages:***
 - ***preparation phase***
 - ***distribution phase***
 - ***electronic phase***
- ***transitional periods till 31.12.2005***

Birth of the EHIC (preparation phase)

Decisions of June 2003 of the Administrative Commission on Social Security of Migrant Workers

- a framework decision***
- a technical decision***
- decision on the replacement of form E111***

Distribution phase

- ***progressive introduction of the EHIC from 1 June 2004 till 31 December 2005***
- ***Yearly assessment of the use of the EHIC***
 - ***no major legal problems***
 - ***significant number of cards distributed (major increase in comparison with former E111)***

Third phase (electronic phase)

- common principle for the creation of the eEHIC adopted by the Administrative Commission in December 2005
- key-points:
 - common objective is a eEHIC with **European interoperability**
 - **national card projects** frame the development of the eEHIC
 - **electronic verification** of validity of the card is the central element of the eEHIC
