 - "direct payments and other aid schemes"
 - product specific presentations





- a list of operating aids and table of their expenditures included
- information for remaining 15 measures (other than operating aids) given in this presentation
 - specific to agriculture, with two exception:
 - duty loss
 - capital injection

- √ Cereal Premium
- √ Mohair (Angora Wool) Support
- ✓ Silk Cocoon Support
- √ Export Refunds

Tea Sector

- area of 76,000 ha
- 202,000 farmers
- 1,200,000 ton/year leaf production (214,000 da/year black tea)
- produced in Eastern Black Sea region (Rize, Trabzon, Artvin, Giresun and Ordu)
- 145 % tariffs for third countries
 (45 % for 200 ton tariff quota for EU)
- EU has no tariffs on tea import
- → need further discussion...

 - ✓ Subsidized Credit Scheme for Farmers (via Ziraat Bank and Agricultural Loans Cooperative Associations)
- b) Forestry sector aids
 - ✓ Individual and Cooperative Based Loans Provided for Forest Villagers
- c) Agro-environmental aids
 - ✓ Environmentally Based Agricultural Land Protection (ÇATAK) Program





Investment Aids: Subsidized Credit Scheme for Farmers (via Ziraat Bank and Agricultural Loans Cooperative Associations)

Aim: to improve productivity and quality of agricultural

products.

<u>Institution</u>: Undersecretariat of Treasury

(subsidizing the difference between the normal and

subsidized rates of Ziraat Bank)

Ziraat Bank and ALCA (implementation)

Legal Basis: Decree No: 2005/8378 (last one)





Instruments and Implementation:

- Ziraat Bank assigned to give soft loans to agriculture
- max. 500,000 YTL (299,490 Euros) credit for livestock breeding max. 250,000 YTL (149,745 Euros) for other agricultural loans
- max. 5 years maturity for investment loans
 max. 18 months maturity for operating loans
- subsidized at 25-60 percent of the Ziraat Bank's current interest rate
- difference between the rates of Ziraat Bank imposes on farmers and market rate → subsidized by Treasury

<u>Duration:</u> scope of scheme revised annually

Expenditure: 2005 → 40 Million Euros – 2006 → 67.2 Million Euros





Forestry Sector Aids: Individual and Cooperative Based Loans Provided for Forest Villagers

Aim: to increase the welfare of forest villagers, protect and

improve the forests

Institution: Ministry of Environment and Forestry

Legal Basis: Communiqué on The Basis and Principles of Forest Villagers Development Services





Instruments and Implementation:

- Direct grant: for the purposes of training, extension, demonstration facilities, individuals or village legal entities may be provided a direct grant
- Soft loan: provided to forest villagers, individually or via cooperatives

<u>Duration:</u> not specified

Expenditure: 2005 → 25,5 Million Euros

2006 → 25,6 Million Euros





Agro Environmental Aids: ÇATAK Program

Aim:

to reduce adverse effects of agricultural practices on environment, to prevent soil erosion, to sustain renewable natural resources, to protect the natural cover and the quality of soil and water

Institution:

Ministry of Agriculture and Rural Affairs (MARA)

Legal Basis:

Law No: 5403 "The Protection of Soil and Use of Land"

Decree No: 2005/9230 "Support to Producers who Prefer Agricultural Practices foreseen in the ÇATAK Program

By-law on Providing Subsidy and Technical Support to the Producers Who Prefer Agricultural Practices Covered in the CATAK Program





Instruments and Implementation:

- direct grant: per hectare, awarded to farmers who select and implement some of the options declared within the regulation
- amount changes according to the categories mentioned in the regulation
- implemented as a subcomponent of Agricultural Reform Implementation Project (ARIP)
- as a pilot implementation for the prospective ÇATAK program

<u>Duration:</u> 2006 – 2007

Expenditure: 2005 → None

 $2006 \rightarrow 7.14$ Million Euros

Animal Husbandry Supports

Aim: to support the development of animal husbandry

Institution: MARA

<u>Legal Basis:</u> Decree on Support for Animal Husbandry (No:

2005/8503)

<u>Instruments and Implementation:</u> direct grant provided to farmers in terms of both production and investment support





a large menu of animal husbandry supports including:

- Milk Premium
- Beef and Veal Premium
- Support for Improvement of the Genetic Resources;
- Support to Increase Fodder Production
- Supporting the Apiculture (Beekeeping)
- Support to the Holdings Which are Free from Animal Disease
- Supporting the Fight Against Animal Diseases
- Support for Animal Registration System
- Support for the Protection of the Animal Genetic Resources
- Support for Milking Hygiene

<u>Duration:</u> 2005-2010

Expenditure: 2005 → 165 Million Euros

2006 → 308 Million Euros





Village Based Participatory Investment Program

Aim: to inc

to increase income in rural areas and to raise social standards by conserving natural resources

Institution: MARA

Legal Basis: By-law on Supporting Village Based Participatory Investment Programs





Instruments and Implementation:

- implemented as a subcomponent of ARIP, as a pilot implementation for the prospective agricultural rural development activities
- direct grant, provided for the investments of agricultural holdings, organizations and public sector
- agricultural investment aids,
- limited to 16 provinces

<u>Duration:</u> 2005-2007

Expenditure: 2005 → None

2006 → 17 Million Euros





Capital Injection to Agricultural SEEs

Aim: to sustain capital structure of agricultural SEEs in

order to keep them in operation

<u>Institution:</u> Undersecretariat of Treasury

Privatization Administration (PA)

<u>Legal Basis:</u> Decree Law, 1984 / 233 (for SEEs under Treasury's portfolio)

Law of Privatization Applications, 1994/4046 (for SEEs under PA's portfolio)





Instruments and Implementation:

- grant state aid to SEEs as capital injection
- transfers limited to;
 - 1- budgetary allocations and availability of Privatisation Fund sources
 - 2- wage and salary expenses of the entities
 - 3- for other expenses of SEEs which have no operational activity, in the process of liquidation

Duration: Not specified

Expenditure: 2005 → 26.9 Million Euros

2006 → 43.0 Million Euros





Duty Loss Payments to Agricultural SEEs

Aim: to meet financial loss of agricultural SEEs

arising from the duties given by Decrees

<u>Institution:</u> Undersecretariat of Treasury

Legal Basis: Decree Law, 1984/233





Instruments and Implementation:

- determined by official audits
- if a mutual debt relationship between the enterprise and state exists, mutual debts can be offset. (Offsetting occurs between the debt of the SEE's to Treasury and receivables of SEEs (duty loss and/or un-paid capital) from Treasury)

<u>Duration:</u> Not specified

Expenditure: 2005 → 1 Billion Euros (including offsetting)

2006 → 110 Million Euros (including offsetting)





Subsidized Credit Scheme for Agricultural Sales Cooperative Associations (ASCAs)

Aim:

to provide subsidized credits to ASCAs to be used for crop purchases, in order to strengthen financial structure of ASCAs during their restructuring period

Institution:

Undersecretariat of Treasury

Legal Basis:

Decree No: 2005/8839





Instruments and Implementation:

- •ASCAs are borrowing from the Revolving Fund to finance their purchases from their partners
- ASCAs are also eligible for short-term (6 months) working capital credits

<u>Duration:</u> related with the restructuring period of ASCAs.

Expenditure: 2005/2006-business period → 144 million Euros credits for 2006/2007 period will be determined once ASCAs prepare their business plans

Aids in case of damages caused by natural disasters or exceptional occurrences: Aid For Farmers Who Suffered From Natural Disasters

Aim: to protect and compensate income of farmers that suffered from natural disasters

Institution: MARA

Legal Basis: The Law Regarding Farmers Who Suffered From Natural Disasters (Law No: 2090)





Instruments and Implementation:

- · direct grant and soft loan
- producers who lose minimum 40 per cent of their agricultural existence because of natural disasters are eligible
- decision by Damage Determination Commissions
- damaged equipment, harvest and farm animals compensated

Duration: not specified

Expenditure: 2005 → 314 Thousand Euros

2006 → 294 Thousand Euros





Aids for Fight Against Animal or Plant Diseases: Supporting the Plant and Animal Health

Aim: to improve plant and animal health and to prevent

contamination of diseases

Institution: MARA

Legal Basis:

- Communiqué on Supporting the Certificated Seeds and Plant with Supporting the Alternative Products Where the Potato Papilloma Appears (Communiqué No:2005/20)
- Decree on Support for Animal Husbandry (No:2005/8503)





Instruments and Implementation:

- plant health: fight against plant diseases and pests, fight against sun pest
- Potato Papilloma: area based payment for the farmers shifting to alternative products in the areas where potato papilloma appears
- supporting the holdings free from animal diseases (in Thrace Region, payment for per head healthy cattle)
- supporting the fight against animal diseases (different kinds of per animal payments when certain criteria met)

<u>Duration:</u> not specified

Expenditure: 2005 → 16 Million Euros

2006 → 18 Million Euros





Aids for Insurance Policies in Case of Natural Disasters and Other Events: Agricultural Insurance Premium Support

Aim: to p

to provide insurance cover for agricultural, livestock, farm fish products, and agricultural constructions and equipments against natural disasters

Institution:

MARA, responsibilities:

- ✓ implementation of the scheme
- ✓ supervision of all operations other than insurance

Undersecretariat of Treasury, responsibilities:

- √ determining rules applicable to insurance contracts
- ✓ supervision of insurance operations

Legal Basis: Law on Agricultural Insurance (Law No: 5363)





Instruments and Implementation:

- based on an insurance pool composed of voluntary participation by insurance companies licensed in agriculture branch
- insurance companies obliged to cede the premiums and the risk to the pool operated by a private company to be founded by the participating insurance companies
- a proportion of the premiums to be paid by the insured party, will be granted by Government

Duration: not specified

Expenditure: 2005 → None (law is not applicable for 2005)

2006 → 112 Million Euros





Start up for Producer Organizations: Social Assistance Support in Rural Areas

Aim:

to support the generation of alternative income and employment opportunities for poor producer who lives in rural areas, to provide social assistance for poor producers

Institution:

MARA and DG of Social Assistance and Solidarity

Legal Basis:

- By-law on Credits for Agricultural Cooperatives
- The related Protocol between MARA and DG of Social Assistance and Solidarity





Instruments and Implementation: soft loans provided for cooperatives:

- · to support for purchasing dairy cattle or sheep
- to co finance a certain amount of green house construction cost
- √ financial source: Social Assistance and Solidarity Fund Budget
- ✓ beneficiaries cannot cumulate with the one under the Scheme
 "Support for Animal Husbandry and Greenhouse Cooperatives"

Duration: 2004-2009

Expenditure: 2005 → 75 Million Euros

2006 → 70 Million Euros





Start up for Producer Organizations: Support for Animal Husbandry and Greenhouse Cooperatives

Aim: to support the producer organizations and to increase

the producers' income

Institution: MARA

Legal Basis: By-law on Credits for Agricultural Cooperatives





Instruments and Implementation: soft loans provided for cooperatives:

- a larger menu (compared to the one funded by Social Assistance and Solidarity Fund Budget) of subjects for cooperatives (eg. beekeeping included)
- according to the budget constraint, supported for their start up expenditures

√ financial source: General Budget

<u>Duration:</u> not specified

Expenditure: 2005 → 54 Million Euros

2006 → 50 Million Euros





Aids For Research and Development: Support for Research and Development Projects

Aim: to provide support for agricultural R&D studies

Institution: MARA

Legal Basis: Communiqué of Support for Research and Development Projects (No: 2005/27)





Instruments and Implementation:

- direct grant provided to the beneficiary whose project found eligible by the Evaluating Committee (set up by GDAR- General Directorate of Agricultural Researches of MARA)
- beneficiaries: individual or legal entity researchers

<u>Duration:</u> 2005-2010

Expenditure: 2005 → 0.9 Million Euros

2006 → 1.7 Million Euros





Other Aids: Land Consolidation and Parceling Activities

Aim: to prevent the fragmentation of agricultural areas and to increase the average holding size

Institution: MARA

<u>Legal Basis:</u> Law of Agricultural Reform on Land Distribution in Irrigable Areas (Law No: 3083)





Instruments and Implementation:

- operational and technical expenditures → MARA during the reparceling (land, personnel, equipment and training of farmers)
- soft loan: if a farmer is entitled for some agricultural land, that is owned by treasury, they pay for that piece of land within a 10 years period, with equal installments, with no interest rate applied
- √ voluntary farmer application required

<u>Duration:</u> not specified

Expenditure: farmers' debt caused by treasury land →appears at the end of the project →no regular and aggregate statistics illustrating the value of those treasury lands
