#### MAIN LEGISLATION FOR SCIENTIFIC COMMITTEES

#### The Food Law no.5179

 Article 11: Scientific Committees are established to search for, to collect, arrange, analyse, interpret, summarise scientific and technical data for risk assessment and to reach an opinion.

Procedures and principles related to scientific committees would be specified by an Implementing Regulation.





#### MAIN LEGISLATION FOR SCIENTIFIC COMMITTEES

#### The Food Law no.5179

- Article 8 of National Food Codex Commission is related to establish specialized sub-committees
- Implementing Regulation on National Food Codex Commission (13.09.2004, No. 25582)
  - Specialized sub-committees (27)





# **II. NATIONAL FOOD CODEX COMMITTEE**







### NATIONAL FOOD CODEX COMMITTEE

- Established : 2004
- Legal Basis : The Article 8 of Law on 5179 Production, Consumption and Inspection of Foods
- Tasks

: The National Food Codex Committee (NFCC) is responsible for preparation and control of Turkish Food Codex.





### NATIONAL FOOD CODEX COMMITTEE MEMBERS

- NFCC composed of 7 members;
- Two representatives of MARA,
- Representative of Ministry of Health,
- Two representatives of Universities suggested by each Ministry,
- Representative of Turkish Standard Institute
- Representative of Federation of Food Association as NGO





### SPECIALIZED SUB-COMMITTEES OF NFCC

Food additives and contaminants. Food hygiene and microbiology, Pesticide residues. Labelling, Veterinary drugs and residues, Methods of sampling and analysis, Foods for special dietary uses, Cereals, legumes and products, Fats and oils, Milk and milk products, Processed fruits and vegetables, Sugar and sugar products, Poultry meat and hygiene, Red meat and hygiene,

Biotechnology, Non-alcoholic beverages, **Spirits** Fish and fishery products, Traditional products, Cocoa and chocolate products, Food import and export, inspection and certification Packaging, Functional foods, Fresh fruits and vegetables, Coffee and chicory, Honey, Spices
