Responsible Authorities

Ministry of Transport (MoT)

For safety of air navigation, MoT together with its related bodies;

- > carries out audits,
- > specifies the criteria for the ATM services,
- > investigates air accidents,
- supervises the implementation of Law on Turkish Civil Aviation.





Responsible Authorities (CONT'D)

Directorate General of Civil Aviation (DGCA)

- > takes necessary measures to avoid infringements
- > specifies and implements the civil-military coordination procedures pursuant to Law on Turkish Civil Aviation
- > makes necessary arrangements for aircraft operations





Responsible Authorities (CONT'D)

DGCA

- > issues, validates, renews or revokes certificates
- makes audits and keeps records for the safety of civil aircraft operations
- determines administrative and technical sanctions to be applied to the legal and natural persons violating the rules,





Responsible Authorities (CONT'D)

DGCA

- determines the rules regarding ATM services in coordination with the relevant bodies
- > investigates and assesses air occurrences and takes necessary measures in coordination with relevant bodies
- > regulates necessary arrangements concerning technical infrastructure,





Responsible Authorities (CONT'D)

Directorate General of State Airports Administration (DHMI)

- > provides nation wide air navigation services;
 - 2 Area Control Centres (size of controlled airspace is 982.099 km²)
 Ankara ACC
 Istanbul ACC
 - 14 Approach Control Units
 - 32 Aerodrome Control Towers





Responsible Authorities (CONT'D)

DHMI

- > operates 36 airports,
- > installs and sets up air navigation systems and facilities and other related systems,
- > provides aeronautical information services,
- provides flight inspection services.





Licensing of Air Traffic Controllers

By-Law on Air Traffic Controller Licensing (SHY 65-01)

- Prepared in compliance with ICAO standards
- Determines the ATCO licensing principles
- Under revision in accordance with ESARR 5 provisions





Reporting and Assessment of Safety Occurrences

By-Law on Reporting and Assessment of Safety Occurrences (SHY 65-02)

- Prepared in compliance with ICAO standards
- Determines the principles of the reporting and assessment of occurrences effecting the flight safety
- ➤ Under revision in accordance with ESARR 2 provisions





Training of Air Traffic Controllers

- ➤ Basic (ab-initio) training is given at the Training Institute of DHMI and Civil Aviation School of Anadolu University.
- Training programmes are approved by DGCA in accordance with EUROCONTROL's common core content.





Route Charges System

- ➤ National cost base figures are determined in accordance with the EUROCONTROL principles, and the conditions of the Route Charge System and Payment are applied.
- Cost base has been established in Euro since 1998.
- In determination of the cost base figures,
 - safety requirements
 - cost effectiveness
 - transparency are taken into account





Civil - Military Coordination

- ➤ Civil and military ATC services are independent from each other.
- ➤ Efficient and well working coordination is maintained through the Civil Military Coordination Group.
- ➤ DGCA, DHMI (ANSP) and Turkish Air Force (Military Service Provider) cooperate for the establishment of policy and airspace management at national level.





Regional Coordination

- Close relationship between Turkey and its neighbouring states
 - optimize regional capacity under the European concepts
 - increase the safety of air navigation services
- > ATM Co-operation in South-Eastern Europe





Regional Coordination (CONT'D)

ATM Co-operation in South-Eastern Europe

Turkey, Bulgaria, Moldova and Romania signed a "Memorandum of Understanding for the Establishment of Air Traffic Management Cooperation in South-Eastern Europe" (08.07.2003).

The aim is to develop a synergy in order to improve and harmonise safety, capacity and cost efficiency in ATM services and to protect the environment.
