COMPETENT AUTHORITY

Ministry of Industry and Trade (MoIT) is responsible from the transposition and implementation of Energy Labelling Framework Directive (92/75/EEC) and its Implementing Directives.

LEGAL FRAMEWORK (COND'T)

All provisions of the related energy labelling directives, have been transposed into national legislation through the Communiqués stated above.

OBLIGATIONS OF MANUFACTURERS AND SELLERS:

- Manufacturer and/or seller shall state information with regard to consumption of electric energy and other energy types,
- Manufacturer shall prepare technical documentation for verification (including model of appliance, main design properties of model together with the related technical drawings, test reports, user guide).





Demand Management - Energy Labelling

ENFORCEMENT

- Manufacturer shall be obliged to secure, and if required, to give all the technical documentation to the MoIT, within 5 years from the production or import date.
- Manufacturer shall prepare the energy label and fiche. Seller shall be severally liable with the manufacturer for the preparation of energy label.
- In the case of distance sales, manufacturer shall submit written communication similar to the fiche.

INSPECTION

 The inspection within the context of these Communiques shall be carried out in accordance with "By-Law Relating to the Market Surveillance and Inspection of the Products (annex of Resolution of Council of Ministers 13 November 2001, no 2001/3529)" by the MoIT.

DG for Consumer Protection and Competition of MoIT: 20 inspectors Provincial Directorates: 600 local inspectors employed in 81 provinces





Demand Management - Energy Labelling

ENFORCEMENT (CONT'D) INSPECTION (CONT'D)

Step 1: Information Availability

The activities of market surveillance and inspection of products on producers and sellers are realized by controlling the existence of related documents, label and fiches, in the case of distance selling the internet mail order catalogues etc. through using a standard minute called "the minute of market surveillance and inspection of products".

Administrative sanctions shall be applied for the ones not in compliance with these Communiqués, after giving 60-day period to manufacturers to end the infringement, a fine of 4,392 YTL (~2,250 Euro) is imposed in case of continuous incongruity upon control at the end of 60 days.

ENFORCEMENT (CONT'D) INSPECTION (CONT'D)

Step 2: Accuracy of Information (Testing Laboratories):

Currently there are no laboratories owned by MoIT. An inventory regarding testing facilities in Turkey has been prepared to determine the competent laboratories.

The potential labs according to this inventory are:

- 'Turkish Standards Institution-TSE' (Ankara Central Laboratory and Gebze Laboratory),
- Istanbul Technical University (Only for Lamps And Ovens)

Related standards

Performance standards; EN 153, EN 60456, EN 61 121, EN 50 229, EN 50 304, EN 814 and EN 255 have been adopted as national standards by TSE).

Technical Committee on Industry of Electric Electronic (ELTEK)
