Overview

STS indicators produced by TURKSTAT (within the frame of STS Regulation)

Annex A (Industry) related indicators

- Industrial Production index has been produced since 1977
- The following indices have been produced quarterly, only for manufacturing industry sector, since 1988:
 - An index of the number of persons employed at production
 - An index of the hours worked in production
 - An indices of the wages per hours worked in production and earnings per person employed
- Producer Price Index (Output Price Index-domestic market) with base year 2003 is produced and disseminated

Overview (cont'd)

Annex B (Construction) related indicators

- Building Construction Cost Index has been calculated quarterly since 1991
- Construction permits have been compiled since 1954
- Occupancy permits have been compiled since 1964

Other indicators

Industrial Tendency Survey has been applied for only manufacturing establishments since 1991

Methodology

Industrial Production Index

Coverage: Sections C to E of ISIC Rev. 3 except Division 12, 37, 41, Class 40.2, 40.3 at national level

Base Year: 1997

Data Source: A survey is applied to the large establishments representing more than 80% of value added of establishments in the base year 1997

Classification: ISIC Rev. 3 for activity, PRODTR for products

Periodicity: Monthly

Dissemination

- A monthly press release both on paper and electronic media
- The test index data have been transmitted to Eurostat since January of 2006

Methodology (cont'd)

Indices of Employment, Hours Worked and Earnings

- Index of the number of persons employed at production
- Index of the hours worked in production
- Index of the wages per hours worked in production and earnings per person employed

Coverage

- The manufacturing industry sector
- Only the data of the employment at production (Earnings also for other workers)
- National level



Methodology (cont'd)

Indices of Employment, Hours Worked and Earnings (cont'd)

Base Year: 1997

Data Source: A survey is applied to large establishments representing more than 80% of value added of establishments in the base year 1997

Classification: ISIC Rev. 3

Periodicity: Quarterly

Dissemination

- A quarterly press release both on paper and electronic media.
- The test index data (employment and hours worked) have been transmitted to Eurostat since January of 2006



Methodology (cont'd)

Producer Price Index

(Output Price Index-Domestic Market)

Coverage: NACE Rev. 1 Sections A (Agriculture) to E (Electricity, Gas and Water) at national level

Base Year : 2003

Data Source: A survey is applied to the sampled producers

Classification: NACE Rev.1

Periodicity: Monthly

Dissemination: A monthly press release both on paper and electronic media

Methodology (cont'd)

Building Construction Cost Index

Coverage:

- Building construction cost in breakdown of material, labour and machinery
- All Turkey in breakdown of 4 climatic regions

Base Year : 1991

Data Source: A survey is applied to the sampled establishments

Classification: Special classification of Ministry of Public Works And Settlement (MPWS) for construction material

Periodicity: Quarterly

Dissemination

- A quarterly press release both on paper and electronic media
- The test index data have been transmitted to Eurostat since January of 2006

Methodology (cont'd)

Construction Permits and Occupancy Permits

Coverage: All building constructions at district level

Data Source

- Administrative registers of municipalities for urban area.
- Administrative registers of MPWS for rural area

Classification: Construction Classification (CC)

Periodicity: Monthly compilation, quarterly dissemination

Dissemination

- A quarterly press release both on paper and electronic media
- Data have been transmitted to Eurostat since January of 2006



Methodology (cont'd)

Industrial Tendency Survey

Coverage: The manufacturing industry sector at national level

Data Source

Web based and postal surveys are applied to large establishments representing more than 80% of value added of establishments

Classification: ISIC Rev. 3

Periodicity: Monthly

Dissemination: A monthly press release both on paper and electronic media
