Overview over **only some** important judgements of the ECJ on equal treatment between men and women.

It is an absolutely essential prerequisite for correct transposition of Directives into national legislation to take notice of the Court's most essential judgements in the area of equal treatment between men and women. The Court is the sole authoritative interpreter of Community law, its judgements are binding for national judges as well as for the national legislator and therefore have to be strictly observed. The Directives as such do not always exclusively reflect the full acquis communautaire.
