#### **Current Situation**

- □ IPA (particularly components II-III-IV) will progressively form the basis for establishment of institutional framework for Structural Funds
- Relevant structures for the management of the IPA are identified






### Political Ownership and Interministerial Coordination

Financial Cooperation Board (FCB) will be established to provide:

- ✓ Overall coherence for financial cooperation with EU as well as participation to Community Programmes and Agencies through political ownership and interministerial coordination
- ✓ Overall monitoring of Turkey EU Financial Cooperation

- Operating Structures





- □ Under the chairmanship of Sectoral Coordinator, Undersecretaries of Ministry of Foreign Affairs, Treasury, Ministry of Finance Operating Structures responsible for each OP and General Secretary of EUSG
- Main Tasks and responsibilities
  - √ Steering the management of SCF
  - ✓ Securing OP's compliance with SCF





### **OP Monitoring Committees**

- ☐ Under the presidency of the operating structure, relevant institutions and NGOs
- Main Tasks and responsibilities
  - √ To steer the preparation of OP
  - √ To monitor OP
  - ✓ To propose amendments for the OP depending on current developments





#### **Accreditation**

- ☐ Already accredited and functioning DIS in Turkey since 2003
- Capacity of CFCU being increased
- Preparations for IPA accreditation underway by NAO
- Studies with operating structures initiated
- □ Technical assistance to be financed from EU funds expected to start by early 2007
- Practical experience (SPO/ISKUR) to be transferred to relevant institutions





### **Prospects for Structural and Cohesion Funds**

- ☐ Certifying Authority : National fund within Treasury
- □ Audit Authority: Board of Controllers within Treasury
- Overall coordination: State Planning Organisation
- MAs for Sectoral OPs: Line Ministries
- □ Potential MAs for Regional OPs: Development Agencies
- Within 2009-10, an interim evaluation planned to;
- Review current structure
- Conduct a gap analysis
- Determine measures for further improvements
- ☐ Take necessary measures for adjustment to final Structural Funds institutions

- ☐ Propose investment programme (Negotiation process with the SPO, final decision by the Council of Ministers)







### Institutional Structure of Ministry of Finance








## **Ministry of Finance**

☐ Coordinates implementation of PIFC system ☐ Responsible for preparation of central government budget draft law and ensures coordination between relevant public administrations ■ Manages central government budget ☐ Preparation and implementation of fiscal policy ☐ Defines accounting standards and provides accountancy services to administrations within the scope of general budget, ☐ Compiles and issues the financial statistics of general government ☐ Determines revenue policy □ Around 5400 auditors and career staff



















### SPO

Composed of two main bodies:
☐ High Planning Council (HPC) as a political commitment
body
☐ Undersecretariat as technical body acting as secretariat of the HPC (around 400 career staff)
Regarding economic and social development policies, SPO;
☐ Advises the government
☐ Coordinates and monitors activities of public institutions
☐ Prepares public investment programmes





## **Institutional Structure of Undersecretariat of Treasury**







### **Undersecretariat of Treasury**

- ☐ Preparing and implementing the debt and cash management policies,
- ☐ Preparing and executing the policies regarding domestic and foreign investment incentives,
- ☐ Preparation of the investment and financing programmes of the SEEs in coordination with SPO.
- ☐ Units dealing with EU funded programmes;
  - ✓ National Fund, with 10 staff including NAO's Office, responsible for channelling EU funds to final beneficiaries and supervision of DIS on behalf of NAO
  - ✓ Board of Treasury Controllers, with 82 staff, responsible for audit
  - ✓ CFCU, responsible for procurement, payment etc.

## **Coordination and Arbitrage**

#### General

- □ Council of Ministers
- ☐ Prime Ministry

Law on Establishment and Duties of the Ministries No. 3046: Ministries are responsible for providing coordination with other ministries and local authorities in their competent areas





# Inter Ministerial Coordination Structures at National Level High Planning Council:

- ☐ Inter-ministerial coordination body
- ☐ Chaired by Prime Minister
- □ Some ministers managing large investment portfolios appointed by Prime Minister
- Undersecretary of the SPO
- □ Depending on topics, chairman can invite ministers and bureaucrats
- ☐ Secretarial services by Undersecretariat of SPO





# Inter Ministerial Coordination Structures at National Level (Cont'd)

#### **Duties of the HPC:**

- □ Provision of assistance to the Council of Ministers in determining policy targets and planning of economic, social and cultural development
- ☐ Examine development plans and annual programmes
- ☐ Taking high level decisions concerning domestic issues and foreign economic relations
- □ Adopt sectoral strategy documents





# Inter Ministerial Coordination Structures at National Level (Cont'd)

#### **Role of Undersecretariat of SPO:**

- ☐ Responsibility in terms of planning, coordination, multi-annual and annual programming, regional development and EU assistance
- ☐ Harmonisation of sectoral and regional policies
- ☐ Horizontal coordination role among ministries and other institutions
- Coordination and guidance for strategic planning
- ☐ Coordination of public investment programme
- Appropriation of national co-financing of investments
- ☐ Sectoral coordination for IPA Components III and IV
- ☐ Vertical coordination between central institutions and development agencies





# Inter Ministerial Coordination Structures at National Level (Cont'd)

#### **Planned Mechanisms**

- □ Regional Development and Human Resources Development Coordination Committee
- □ Technical studies underway for further development of interministerial coordination mechanisms related to regional development policy through twinning project initiated in June 2005





## **Coordination Structures at Regional Level**

Development agencies will coordinate regional development activities at regional level

- □ Administrative Board of Agencies :
  - ✓ Governors, mayors, representatives of provincial council, chambers and private sector
  - ✓ Main coordination and decision making body for the Agency
- □ Development Councils: Mechanism to enhance coordination among public institutions, chambers, private sector, NGOs, universities and local authorities





#### **Coordination Structures at Provincial Level**

#### Governor:

- Coordinates deconcentrated units of ministries
- Supervises local authorities

#### **Provincial Coordination Boards:**

- ☐ Provincial directorates of line ministries and local authorities
- Coordination of public investments at provincial level
- Meet four times a year





## IV. Partnership





## Partnership at national, regional and local level

Partnership applied in:

- ☐ Macro planning documents
- Regional and sectoral strategies
- Institutional strategic plans
- Project preparation process





## **Main Regulations on Partnership**

- 1) Decree-Law on the Establishment and Duties of the SPO No. 540, Undersecretariat of SPO works in close cooperation with public and private institutions in preparing macro plans and monitoring the implementation
- 2) Law on Establishment and Working Principles and Procedures of the Economic and Social Council No. 4641
- 3) Law on Establishment and Duties of Development Agencies, Development Councils No. 5449





## Main Regulations on Partnership (Cont'd)

- 4) Law on Municipalities No. 5393, City Councils
- 5) Law on Public Financial Management and Control No. 5018, necessary basis for institutional strategic plans to include partnership
- 6) By-law on EIA, participation important in EIA process, takes various forms including public participation meetings





# Main Mechanisms for Partnership and Participation of Socio-Economic Partners

- □ Ad Hoc Committees for preparation of development plans
- Economic and Social Council at national level
- □ Development Council of Development Agencies at regional level
- City Council at local
- City Council at local level





# Main Mechanisms for Partnership and Participation of Socio-Economic Partners (Cont'd)

### Ad Hoc Committees for preparation of development plans:

- Basis for preparation of development plans
- ☐ For 9th Development Plan, 57 Ad Hoc Committees, representatives of all economic and social actors
- ☐ Public institutions, local authorities, unions, NGOs, private sector and universities





# Main Mechanisms for Partnership and Participation of Socio-Economic Partners (Cont'd)

#### **Economic and Social Council**

- □ Consultative council for development of economic and social policies
- ☐ 39 representatives, 15 members representing the government, others from the private sector and civil society organisations





# Main Mechanisms for Partnership and Participation of Socio-Economic Partners (Cont'd)

#### **Development Agencies: Development Council**

To enhance cooperation among public institutions, private sector, chambers, NGOs, universities and local authorities in the region

- ☐ Discuss and evaluate annual activity and internal audit reports
- Make recommendations to Administrative Board regarding problems, promotion, potential and priorities of the region

☐ Municipal Level
☐ Renders opinion to Municipal Council in a wide range of
