- ✓ EUROPASS documentation translated into Turkish, August 2005.
- ✓ Contact information regarding Reference Points and Europass Center Networks
- ✓ Yet, no arrangement for establishing a National Europass Center in Turkey
- ✓ However, Europass implementation adapted by the MoNE and related activities are still ongoing.
- ✓ Participation in Language Portfolio activities of the Council since 2001.

#### **ETF-CEDEFOP**

- ✓ National Vocational Competency works carried with ETF
- ✓ Turkey has two representatives in Advisory Committee of ETF
- ✓ By the end of 2004, ISKUR initiated cooperation with CEDEFOP in relation to the reporting and documentation activities.
- ✓ Vocational publication (Vet-Bibb), vocational training institutions (Vet-Instit) entered into CEDEFOP (Refernet).
- ✓ Activities of National Observatory
- ✓ National Observatory Country Report prepared and revised every year.
