NATIONAL LEGISLATION AND INSTITUTIONS INVOLVED

- ■The Undersecretariat for Maritime Affairs is responsible to apply and to inspect all the international regulations for ships according to the SOLAS Convention, MARPOL Convention (Annex I, II and V) and IMDG Code.
- Motor vehicles and trailers designed for transport of dangerous substances (covered by 98/91/EC) are approved and registered for traffic by the Ministry of Industry and Trade

NATIONAL LEGISLATION AND INSTITUTIONS INVOLVED (CONT'D)

By-Law on Industrial Air Pollution Control;

Installations are identified in,

- Annex III, Paragraphs 9.1 and 9.2 which lists the activities and storage facilities subject to emission permit.
- Article 43.Y defines emission limit values, techniques and standards to be applied in petroleum storage facilities- for both fixed and floating roof.

NATIONAL LEGISLATION AND INSTITUTIONS INVOLVED (CONT'D)

By-Law on Industrial Air Pollution Control;

- Article 39 describes requirements for general cases, limit values in case certain substances such as toxic, carcinogenic or persistent pollutants are involved or emitted in the process
- Article 40 prescribes monitoring of air quality in the plant impact area and estimation of plant's contribution to the local air pollution when needed

INSTITUTIONAL FRAMEWORK

•MoEF is the competent authority for issuing emission permit to petroleum storage facilities.

•EMRA grants licences for service stations after all responsibilities are fulfilled according to Workplace By-law. EMRA is also the competent authority for licensing storing terminals.

CHALLENGES

Transposition:

 A framework regulation meeting the requirements of the Directive should be made with contributions of related institutions.

Implementation:

- Preparation of an inventory of the plants, storage facilities, etc. covered by the directive
- Meeting the requirements of the Directive for existing installations, especially small enterprises, due to high investment costs

• Institutional restructuring:

 Establishing an effective permitting, monitoring, coordination and inspection system to reduce VOC emissions in harmony with the Directive
