LEGISLATIVE AND INSTITUTIONAL FRAMEWORK

Main institutions and agencies responsible for civil protection in Turkey

At national level

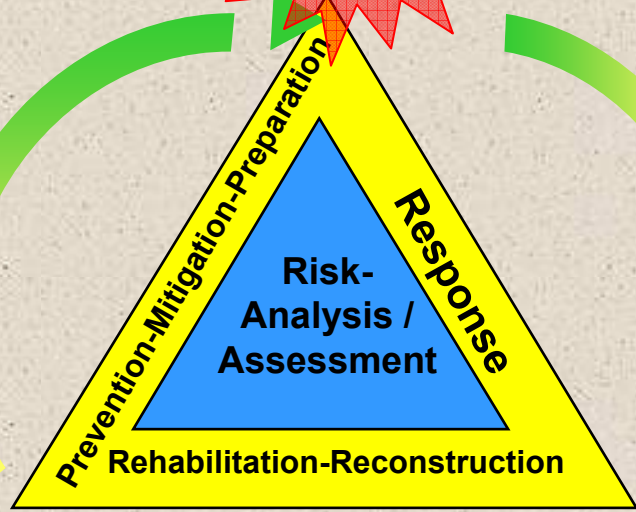

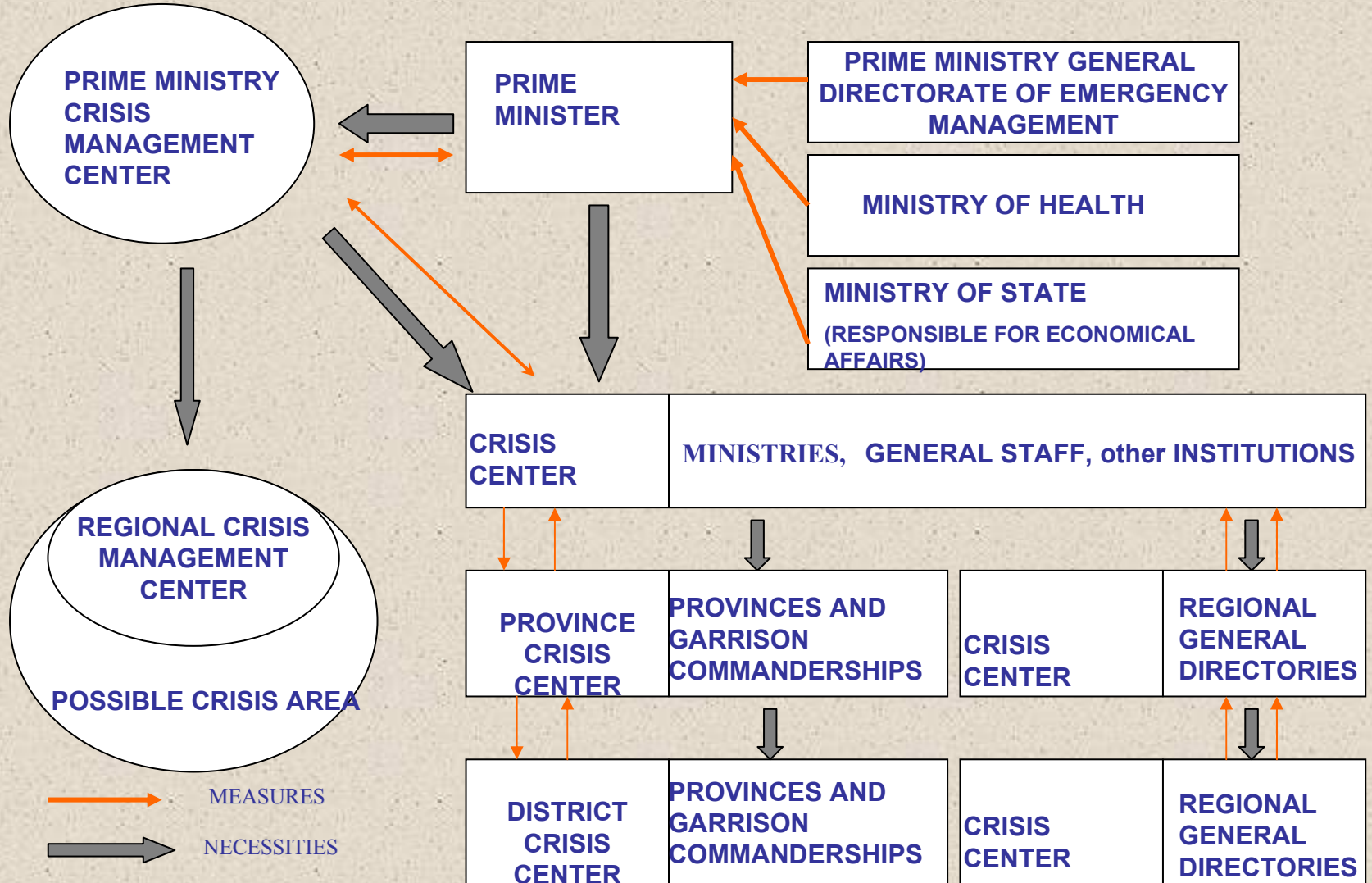
