#### Background

- 1994: Council adopted Directive 94/47/EEC on Timeshare.
- 1999: Commission adopted a Report on the Implementation of the Directive
- 2000: Council adopted conclusions on the report
- 2002: EP adopted Resolution on application of the Directive.

#### Commission's actions to date

- 1999: Commission adopted a Report on the Implementation of the Directive :
  - Analysis of the transposition measures taken by MS
  - Identification of problems occurred since adoption
  - Launched a discussion on better implementation
- 2002: Adoption of Communication on the Consumer Policy Strategy 2002-2006. A review of all the consumer policy acquis was foreseen.
- 2004: Regulation of 27 October 2004 on Consumer Protection Cooperation,
- 2005: Directive 2005/29/EC on Unfair Commercial Practices (UCP).
- 2006 : Commission launches Consultation Paper on the review of the Directive.

## Review of the consumer policy acquis

• The minimum harmonisation approach has led to differences in the degree of protection afforded to consumers.

• The sectoral approach has also led to inconsistencies between the different Directives.

• The Commission fears these differences may create internal market problems.

# Directive 94/47/EEC on Timeshare. State of play

- Checking the implementation of new MS, completed
- Launching infringement proceedings, if necessary,
- Review of the Directive (meetings with stakeholders)

#### LACK OF ENFORCEMENT

• Inappropriate enforcement of national rules,

Insufficient provisions at national level

Entry into force of the Regulation on Consumer Protection Cooperation (end 2006)

## ISSUES REQUIRING AMENDMENTS TO THE DIRECTIVE

- New definition of timeshare contract (the question of Holiday Clubs and Travel Discount Clubs),
- Harmonisation of cooling-off period,
- Timeshare rights held by virtue of ownership of share in a company,
- Contractual obligations of the vendor,

### ISSUES TO BE COVERED BY THE UCP DIRECTIVE

(December 2007)

Misleading statements about inducements to buy,

Aggressive selling techniques

## ISSUES THAT MAY REQUIRE BOTH AMENDMENT TO THE DIRECTIVE AND UCP

• Timeshare resales,

Timeshare exchanges,

Holiday/Vacation clubs.
