Article 152 Public Heath

- A high level of human health protection the definition and implementation of all Community policies and activities.
- Community action, which shall complement national policies, shall be directed towards improving public health, preventing human illness and diseases.
- The Community shall encourage cooperation between the Member States in the areas referred to in this Article and, if necessary, lend support to their action.
- Member States shall, in liaison with the Commission, coordinate among themselves their policies and programmes.... The Commission may, in close contact with the Member States, take any useful initiative to promote such coordination.
- The Council may adopt... incentive measures, excluding any harmonisation of the laws and regulations of Member States

- give specific attention to the impact of stigma and discrimination due to mental illness in all age groups,
- give special attention to the reduction of risks of social exclusion;
- collect good quality data on health, economic and social consequences of stigma due to mental illness;
- -undertake action to combat stigma and promote social inclusion in active partnership and dialogue with all the stakeholders.





Council Conclusions 9805/05 on a Community Mental Health Action of 3 June 2005,

- Implement the Declaration and Action Plan endorsed by the World Health Organisation European Ministerial Conference on Mental Health,
- collect good quality and comparable data on mental health, and on the economic and social consequences of common mental health problems,
- implement comprehensive, integrated and efficient mental health systems that cover promotion and prevention together with treatment

Council Recommendation on the prevention and the reduction of health-related harm associated with drug dependence (Official Journal L 165, 03/07/2003 P. 0031 – 0033)



Member States should, set as a public health objective the prevention of drug dependence and the reduction of related risks, and develop and implement comprehensive strategies accordingly.



make available, a range of services and facilities, particularly aiming at risk reduction; especially to reduce the incidence of drug-related health damage such as HIV, hepatitis B and C and tuberculosis and the number of drug-related deaths,



develop appropriate evaluation to increase the effectiveness and efficiency of drug prevention and the reduction of drug-related health risks;





report to the Commission on the implementation of this recommendation

Recommendation (2001/458/EC)
of the Council of 5 June 2001 on the drinking
of alcohol by young people, in particular
children and adolescents





What it says

All Member States should initiate or develop public health promoting/ preventing efforts directed at young people to reduce alcohol harm and under-age drinking (research, education, law enforcement, awareness raising)



establish/enforce self-regulatory controls on commercial communication (not target youth, in commercial communication, not to sell to under-age people)



A report on the implementation of the proposed measures will be presented to the Council in 2006,





Conclusion (2001/C 175/01) on a Community strategy to reduce alcohol-related harm.





What it says

The Commission is invited to put forward proposals for a comprehensive Community strategy and a timetable for different actions



A Communication on Alcohol and Health is planned to be presented in 2006

Council recommendation, 2003/878/EC of 2 December 2003 on cancer screening. Official Journal L 327, 16/12/2003 P. 0034 – 0038

MS should offer evidence-based cancer screening

Implement screening programmes in accordance with European guidelines on best practice





- cervical cancer pap smear starting not before the age of 20 and not later than the age of 30;
- breast cancer mammography for in women aged 50 to 69 in accordance with European guidelines on quality assurance in mammography;
- colorectal cancer faecal occult blood screening for in men and women aged 50 to 74.
