CUSTOMS COOPERATION AGREEMENTS

- Protocol with Bulgarian Customs regarding some facilitated procedures for vehicles passing through border crossing points between Bulgaria and Turkey (2004)
- Two joint declarations were signed with German Customs Administration
- Memorandum of Understanding with Georgia to enhance the co-operation (26.01.2005)
- Container Security Initiative (CSI): Implementation in İzmir port is under negotiation with US (2004)
