







# Civil Society Support Programme Period III

#### **Foreword**

Strengthening civil society is one of the priority areas within the scope of the financial assistance that Türkiye has benefited from during its accession process to the European Union (EU). In the third period of the Instrument for Pre-Accession Assistance (IPA) covering the years 2014-2020, "Civil Society" has been defined as a sub-sector under the Democracy and Governance Sector; and The Ministry of Foreign Affairs Directorate for EU Affairs has been authorised to formulate the strategy for the use of the budget allocated to support the civil society sector in Türkiye and to carry out programming, project identification and monitoring.

Attaching importance to the development of civil society in Türkiye, the Directorate for EU Affairs, with a sectoral and systematic perspective, has gathered the support provided to civil society and its actors under the umbrella of the "Civil Society Sector". Under this umbrella programme that brings together public institutions and civil society organisations (CSOs), many projects in different fields have been implemented, the capacities of CSOs have been improved, and the foundations of working, producing and living together have been strengthened.

The Civil Society Support Programme First Phase (CSSP-I), which was implemented between 2018-2021 under the Civil Society Sector, aimed to ensure more effective participation of CSOs in decision-making processes, improve public-civil society relations at local and national levels, and support CSOs' management, advocacy and communication skills. Approximately 6.3 million euros of grant was provided to 48 projects during CSSP-I.

CSSP-II, which was implemented as a continuation of the first period and carried out between 2019-2021, aimed to build a stronger civil dialogue and participation and to develop the capacities of CSOs with a grant support of 3.7 million euros provided for 29 projects.

In the CSSP-III period (2021-2022), which was a continuation of the previous Civil Society Support Programmes, it was aimed to strengthen CSOs' structures and institutional capacities, capacities to participate in decision-making processes, cooperation and networking skills; to encourage CSOs' participation in decision-making processes at local, national or international levels; and to support the development of the legal environment for active citizenship. During the CSSP-III period, 34 projects were supported with a grant of 3.2 million euros.

In this project catalogue, we are pleased to share with you the stories of the projects carried out in the third term of the Civil Society Support Programme. We sincerely congratulate all CSO representatives who have contributed to the projects and wish that their successfully completed projects will inspire other CSOs.

## Civil Society Support Programme (CSSP) from Past to Present

With the Negotiation Framework Document and the Copenhagen political criteria, civil society came to the fore as an important actor in Türkiye's accession negotiations to the European Union (EU). The understanding that a healthy functioning democracy, reaching EU standards and establishing lasting ties between Turkish and EU societies can only be possible with a strong civil society, thus, gained importance.

Civil society supports, provided in different areas until 21014, were gathered under the umbrella of the "Civil Society Sector" in the Second Period of the EU Instrument for Pre-Accession Assistance (IPA II) covering the years 2014-2020. The Ministry of Foreign Affairs Directorate for EU Affairs became the lead organisation of the Civil Society Sector, responsible for programming, implementation and monitoring.

Within this framework, Civil Society Support Programme-I (CSSP-I) and Civil Society Support Programme-II (CSSP-II) were successfully completed with 77 projects with a total budget of 11 million euros between 2018-2021.

Within the scope of the Civil Society Support Programme-III (CSSP-III), which is the continuation of CSSP-I and CSSP-II, 34 projects under the themes of environment, youth, culture and arts, vulnerable groups and cooperation were successfully implemented with a total budget of 3.6 million euros.

#### Civil Society Support Programme First Phase (CSSP I) (2018-2021)

The first phase of the Civil Society Support Programme (CSSP-I) enabled CSOs to participate more effectively in decision-making processes, improved public-civil society relations at local and national levels, and CSOs' management, advocacy and communication skills were supported.

The first phase of the Civil Society Support Programme consisted of the following components:

- Partnerships and Networks Grant Scheme for Strengthening Cooperation between **Public Sector and CSOs**
- Local CSOs Grant Programme

"The Partnerships and Networks Grant Programme for Strengthening Cooperation between Public Institutions and CSOs" supported partnerships and networks to be developed by CSOs that were financially and administratively strong and experienced in project management. Through these partnerships and networks, the cooperation between public institutions and CSOs and the capacities of CSOs were strengthened. Within the scope of the programme, 10 CSOs received grants of approximately 4.2 million euros.

With the "Local CSOs Grant Scheme", which has a budget of 2.1 million euros, the institutional capacities of CSOs were strengthened, lobbying and advocacy activities were supported and communication skills were improved. The programme, which included 38 projects from 15 different provinces of Türkiye, played an important part in the dissemination of EU funds to Anatolia.

Within the scope of CSSP-I, 28 networks/platforms were formed with the participation of 2223 CSOs and 14 Public-CSO cooperation protocols were signed.

#### **Civil Society Support Programme Second Period (CSSP-II) (2019-2021)**

The Second Phase of the Civil Society Support Programme, which was implemented in 2019 as a continuation of the first phase, was implemented with a budget of approximately 4 million euros to improve the capacities of CSOs for a stronger civil dialogue and participation.

29 projects from 10 provinces in Türkiye were supported with a grant of 3.7 million euros. Although there was no partnership requirement, 18 projects set off with a co-beneficiary. Co-beneficiaries from the Netherlands, Germany, Italy and Austria also joined the programme with their Turkish partners. CSSP-II contributed to building the capacities of CSOs for stronger civil dialogue, participation and recognition.

Within the scope of CSSP-II, it was of prior concern:

- · to ensure the administrative and financial sustainability of CSOs,
- to increase their communication and advocacy skills,
- to improve their participation in decision-making processes at local, national and international levels,
- to strengthen their transparency and accountability,
- to improve their role in promoting active citizenship.

The programme reached out to a wide range of CSOs operating in various sectors such as health, agriculture, education, environment, food, media, health, agriculture, education, environment, environment, food, media, including different target groups such as women, children, youth and disadvantaged groups.

5,349 people participated in 193 training programmes conducted under CSSP-II. The capacity of 576 CSOs was improved through the projects implemented.

#### Civil Society Support Programme Third Period (CSSP-III) (2021-2022)

CSSP-III, which is a continuation of the previous Civil Society Support Programmes, was implemented in a way to cover CSOs in EU countries and candidate countries as well with respect to the same priority areas. Within this context, 34 projects were supported with a grant of 3.2 million euros.

With these supports, it was aimed to:

- Improve the institutional capacity of CSOs,
- Promote partnerships among CSOs,
- Strengthen active citizenship and the participation of CSOs in decision-making
- Develop the legal framework for active citizenship.

### Civil Society Dialogue (CSD)-VI **Programme and Civil Society Support** Programme (CSSP)- III Technical **Assistance Project**

#### **Grant Implementation Trainings**

5-7 April, 7-9 April, 12-14 April 2021

Grant Implementation Training for CSD-VI and CSSP-III projects was organised in three groups. The first group of the training was face-to-face, the second was organised online for grant beneficiaries of Türkiye-based CSOs and the last training was organised for grant beneficiaries of EU-based CSOs. A total of 152 people from 66 grant projects participated in the training programmes.

#### Civil Society Dialogue VI and Civil Society Support III Launch Event

8 October 2021

The grant programmes were introduced to the public at the Launch Event held in Istanbul with the participation of 203 people. A networking activity was organised within the scope of the event. The importance of grant programme supports for CSOs to strengthen their capacities and increase their cooperation with other partners in the EU was highlighted. 88 news items related to the launch event appeared in national and local media.

#### **Communication Training**

7 October 2021

The Opening Event was combined with the Grant Programmes Communication Training, allowing participants to interact for a longer period of time.

#### Focus Group Meeting entitled "Why Does the Civil Society Sector Care About Social **Entrepreneurship?"**

22 November 2021

As part of the Global Entrepreneurship Week, an online event was organised with the participation of 99 people to raise awareness on social entrepreneurship, share information on current developments and good practices, and discuss the needs of grant beneficiaries together with social entrepreneurs.

#### Civil Society Meetings: Second National Consultation Meeting on Civil Society **Dialogue and Civil Society Support Programmes**

25 November 2021

In the meeting held with the participation of 190 people from civil society organisations, public institutions and stakeholder groups, the thematic priorities of the grant programme were highlighted and 5 thematic support areas of the grant programmes were discussed.

#### **Post-Grant Evaluation Interviews**

23 February 2022

In order to assess the overall impact of the programmes, online in-depth interviews were conducted with 14 project teams from CSD-IV and 12 from CSSP-III. Moreover, all project teams were directed to online surveys. 57 grant project teams participated in the surveys.

#### **Social Entrepreneurship Training**

24-25 February 2022

During the training organised in Ankara with the participation of 25 experts from the Directorate for EU Affairs, participants shared knowledge and experience on social entrepreneurship and its impact and role in the civil society sector. Following the face-to-face training, a half-day online interactive event was organised to reinforce the information conveyed during the training process.

#### **Final Report Training**

9-11 March 2022

A final report preparation training was organised in Ankara with the participation of 8 experts from the Directorate for EU Affairs, 15 representatives from the Central Finance and Contracts Unit and 68 grant beneficiaries.

#### **Online "Final Report Training"**

14-16 March 2022

Online training was held on 14 - 16 March 2022 for grant beneficiaries who could not attend the face-to-face final report training. The online training on preparing the project final report for grant beneficiaries from Türkiye and EU countries was held in two different sessions in English and Turkish. 40 representatives of CSD-VI and CSSP-III projects participated in the online training.

#### **Impact Investing and Civil Society Conference**

29 March 2022

A small-scale meeting was held in Istanbul with the participation of 60 representatives from 33 different organisations, including public institutions and CSOs. The meeting aimed to discuss the impact investing model, which focuses on generating financial returns by creating positive and measurable social and environmental benefits, with civil society representatives and impact investors in Türkiye.

#### **Social Entrepreneurship Training**

19 April 2022

During the online training with the participation of experts from the Directorate for EU Affairs, experts were informed about the basic concepts of social entrepreneurship. Throughout the training, experts were provided with detailed and up-to-date information to follow the practices of grant beneficiaries implementing social entrepreneurship projects and contribute to their future planning.

#### **Civil Society Dialogue Türkiye Network Meetings**

April-May-June 2022

A series of meetings were held in which the potential benefits, limits and constraints of the network were discussed; network types and models in Türkiye were reviewed; the vision and mission of the network were determined; the work plan was outlined; and, potential stakeholders for the establishment of the network were evaluated.

#### **Local Good Practices Meeting**

5 July 2022

The meeting, held in Bursa with the participation of 63 representatives from 43 different organisations, aimed to provide a platform for sharing experiences. During the meeting, experiences and local good practices on public-civil society cooperation, advocacy and capacity building of CSOs were shared, and medium and long-term cooperation opportunities were discussed.

#### Focus Group Meeting on "Public-Civil Society Cooperation from the 11th Development Plan to the 12th Development Plan"

7 October 2022

A meeting was organised in Ankara to discuss the progress made in public-civil society cooperation practices since the adoption of the 11<sup>th</sup> Development Plan.

#### **Dialogue and Support Programmes Evaluation Meeting**

28-30 November 2022

The last focus group meetings were held in Izmir with 34 participants to assess the implementation processes and results of CSD and CSSP programmes, networking and dialogue capacity and good practices.

#### **Advanced Project Management Training**

7-8 December 2022

It was held with the participation of 25 experts from the Directorate for EU Affairs.

#### **Closing Event**

19 December 2022

A closing event for the CSSP-III and CSD-VI Grant Programmes was held in Antalya with the participation of 210 people.

#### **National Consultation Meeting themed "Civil Society Seeks Its Future"**

20 December 2022

The meeting, which was held to evaluate the programmes from different perspectives and to discuss the mechanisms established for the sustainability of cooperation and dialogue, was attended by 178 participants from CSOs, public institutions and other stakeholder groups.

#### **Study Visit to Spain**

24-25 January 2023

In order to promote the Civil Society Dialogue Türkiye Network, a study visit to Barcelona was organised with the participation of 14 people from the network member civil society organisations, the Directorate for EU Affairs and the Central and Financial Contracts Unit.

#### **Study Visit to Germany**

16-17 May 2023

In order to promote the Civil Society Dialogue Türkiye Network, a study visit to Berlin was carried out with the participation of 14 people from the network member civil society organisations and the Directorate for EU Affairs.

#### **Study Visit to Italy**

29-30 May 2023

In order to promote the Civil Society Dialogue Türkiye Network, a study visit was made to Rome with the participation of 16 people from the network member civil society organisations and the Directorate for EU Affairs.

#### **PROJECT OBJECTIVES**

The project was carried out so as to improve the institutional capacity of the Laughter Heals Association, which acts as a resource centre for Turkish civil society representatives dedicated to improving the welfare of children with cancer. Within this framework, structured committees were formed with the support of existing volunteers, effective training/monitoring/supervision programmes were developed and communication was strengthened.

- A toolkit containing all the training modules developed within the project, best practices from EU Civil Society Organisations, strategic tools, communication tools, printed materials and manuals was produced.
- 45 CSOs were contacted, 20 of these CSOs volunteered to participate in the project, three meetings were organised with the participation of 28 CSO representatives and project outputs were
- 22 volunteer training sessions were conducted, aiming to improve volunteers' skills in meeting the needs of children with cancer and their parents.
- A 10-member, effectively functioning Volunteer Training Committee was established.
- The organisational, professional and administrative skills of 148 volunteers at Laughter Heals Association were improved.
- 516 children with cancer and their families were reached, enabling them to enrol in the Hygienic Play Centres and benefit from the centre's services or online classes.
- A "Parent Mentoring Committee" consisting of 1 mentoring coordinator, 1 psychologist and 9 volunteer parents of children with cancer was established and a communication network was created between mentors and families who wanted to benefit from mentoring services.
- 181 people participated in 13 mentoring training sessions, a total of 57 mentors and 57 beneficiary families were reached.
- Within the framework of the project communication plan, a total of 12.4 million people, mostly women, were reached through the social media campaign.
- 47 doctors and healthcare staff from 21 hospitals in 8 provinces were interviewed through 19 online and two face-to-face meetings; 2000 brochures were sent to 23 hospitals and 29 paediatric centres in 9 different provinces.
- News about the hospital and pharmacy visits was published in five magazines for healthcare professionals, thus reaching 490,000 people.
- At the pharmacists' congress held in Antalya, 2000 brochures were distributed to 500 participating pharmacies; 700 pharmacists and doctors were reached in three days at the Open Stage Awards organisation, which was attended by doctors and pharmacists; 107 pharmacies actively participated in project activities.
- A new inspection programme was organised to assess the quality of staff activities and the functioning of Hygienic Play Centres (HOMs).

Our project has set out with the aim of improving TEGV's relations with its stakeholders and strengthening the technology skills of CSOs while doing so. The project aims to develop best practices to encourage active democratic participation of CSOs in policy and decision-making processes through capacity development. Within the project, steps have been taken to improve the effective use of CRM, the development of customised communication strategies, active citizenship and volunteering.

#### **PROJECT OBJECTIVES**

The project was implemented so as to improve the institutional capacities of CSOs active in the field of education and to promote democratic participation of CSOs in decision-making processes. Within this context, good practices of customer relationship management (CRM) were developed, aiming to improve the communication skills of education-focused CSOs and strengthen their administrative and financial sustainability.

- CRM strategies were developed to enable the establishment of relationships between CSOs, and TGEV's CRM system was developed in a comprehensive and integrated manner, thereby increasing individual and regular donors.
- © CSOs' technology skills for visibility and promotion of their work were enhanced; two online and one hybrid CRM training sessions were conducted with the participation of 182 CSO representatives and one hybrid human resources management training was conducted with the participation of 76 CSO representatives.
- Active citizenship and participation of CSOs in decision-making processes at a national level were promoted; two workshops were organised with the participation of 8 CSO representatives, resulting in a policy document.
- In order to increase the visibility of the project and ensure the dissemination of the project outputs, the project web page was published; social media channels were actively used; a project booklet was prepared and distributed at the project closing conference.

In order to alleviate the use of discriminatory language against women in the media, we raised awareness through the events we organised for the dissemination of 'gender-oriented' journalism and the elimination of language that legitimises violence and discrimination against women in the media; the strengthening of women's place in society and their participation in policy and decision-making processes; and the publication of these events in conventional media and new media. We established the Media's Women's Language Call Centre. We made the short film 'I Don't Exist'.

#### **PROJECT OBJECTIVES**

The project was carried out so as to support greater participation of women in policy and decision-making processes by using the media as a tool. Within this context, it was aimed to develop women's communication and advocacy skills to support active citizenship and to create a platform that would contribute to gender equality.

- Women's awareness of discriminatory language was raised and advocacy skills were developed through printed and visual materials, workshops and training programmes.
- A one-day training was given to 135 students on "basic definitions and concepts of media literacy, media literacy in the world and in Türkiye, analysis of relevant institutions, media literacy models and techniques, the concept of critical reading, content production in the media or content production for target audience".
- A code of ethics, which sets out the scope of professional rules and responsibilities adopting the principles of justice, respect, responsibility, moderation, transparency, courtesy and confidentiality in communication and media, was prepared and sent to various media organisations.
- Advocacy and lobbying training of two days was provided in Ankara and Ordu to a group of 112 participants from communication associations, representatives of CSOs dealing with women's issues, students and media members from across Türkiye.
- A handbook on how discriminatory language exists in the media, how it is used and what kind of news should be reported in the media was produced and distributed to 600 women.
- A short film about how the discriminatory language used in the media shapes the perception of the society and what consequences this situation can lead to in the society was shot and broadcasted on social media and 10 TV channels, reaching 3000 people.
- A call centre has been established to which women can apply in cases of discrimination, violations of their rights and breaches of the respect framework.
- The Turkish Grand National Assembly Commission on Equal Opportunities for Women and Men was visited and active participation of CSOs in decision-making mechanisms was ensured.
- A web-based platform was created with the idea of promoting gender equality and spreading human rights to everyone.
- 10 volunteers were trained on discrimination, rights violations and gender equality and then these volunteers provided mentoring services through the platform.

The project was carried out so as to increase UCIM's active democratic participation in policy and decision-making processes, ensuring its financial sustainability and strengthening it institutionally. The project aimed to develop a sustainable donation/ fundraising system with a social entrepreneurship logic; to increase UCIM's advocacy and partnership capacity; and to raise awareness on the prevention of child abuse, children's rights and active citizenship.

- Within the scope of training of trainers, two new training modules and training sets were created; a total of 40 volunteers from UCIM were trained.
- UCIM staff and/or volunteers were trained on effective communication, parent and child, legal counselling, children's rights, psychological counselling, physical speech with creative drama, physical speech with Lego, UCIM institutional presentation and as a result, a trainer pool of 88 trainers was formed.
- A total of 207 UCIM employees/volunteers and representatives of different CSOs working in the field of children's rights from 7 regions of Türkiye were trained by UCIM trainers.
- A total of 586 people's awareness was raised in these areas through the promotion of UCIM and online seminars organised on children's rights, privacy and active citizenship in Türkiye.
- A total of 291 children, 305 parents and 108 teachers were reached in Ağrı, Antalya, Bursa, Gaziantep, Izmir, Kayseri, Konya, Mardin, Ordu, Van, Mersin and Ankara within the scope of "Physical Right to Speak with Creative Drama Training".
- A total of 155 students, 238 parents and 32 teachers from Istanbul, Ankara, Erzurum, Izmir and Konya were reached within the scope of " Physical Right to Speak with LEGO " training.
- As a result of the training on communication, social media and modern digital tools/software, the contribution of UCIM's communication team to the content produced for social media and other communication tools was increased.
- UCIM Communication, Membership and Campaign Strategy Plan was prepared and implemented.
- Three short films and a documentary on UCIM promotion, child abuse and neglect were prepared, broadcast on national TV channels and viewed approximately 300,000 times through social media.
- Organised jointly with RTÜK, the Child Friendly Broadcasting Workshop was attended by 54 representatives from UCIM, RTÜK, national TV channels and the Ministry of Family and Social Services.
- In the meeting held in Istanbul with 20 mother bloggers and UCIM representatives, the concepts of children's rights and child confidentiality were discussed, and mothers' awareness was raised with a presentation on preventing child neglect and abuse.
- 12 families were supported in legal processes in cases of child abuse.
- Public, CSO and other institutions (including supervisory boards, bar associations, sports clubs, embassies, universities and governorships) were visited and a total of 39 people were reached in order to solve the problems of child abuse victims, to provide training to prevent child abuse and to raise awareness on this issue.

- A total of 42 CSOs, 26 of which were established by Syrians in Türkiye, were researched and mapped. Based on this study, a capacity building plan for CSOs was prepared.

- At the end of the strategic analysis, planning and institutional development training programme, 9 strategic plans were prepared by the participants.

It has also contributed to widening the circle of independent living assistants in Türkiye and strengthening their capacity to advocate for independent living.

We developed the capacity of the Electricity Distribution Services Association through civil society and public partnerships, and endeavoured to promote occupational health and safety culture in the electricity distribution sector in Türkiye.

We have developed the capacities of environmental associations operating in Antalya on forest management and the protection of endemic plant species. By creating a digital platform, we aimed these associations would both introduce themselves and establish cooperation within the platform. We carried out field studies on fifteen target species of local endemic plant species scattered in Antalya. In these studies, threat factors and protection measures were determined and these data were shared with the Regional Directorate of Forestry. We organised competitions to increase the awareness of future generations about forest and endemic plant species.

- A total of 55 children participated in the project activities.
- Through the study visit to Poland, good practices were observed on site and a current situation report was prepared including the outputs of the literature review, EU good practices and study visit outputs.
- For Theoretical training activities focusing on environment and climate change were provided for CSO and stakeholder representatives and children; and training programmes on good practices in agriculture were organised.
- A publication on "children's policy recommendations" was prepared and disseminated with the participation of children; it was presented to private sector representatives during visits, planned by children, to environmental friendly employers.

### **PROJECT OBJECTIVES**

The project was carried out so as to make all actors working in the field of cultural heritage more effective in both local and national decision-making and implementation processes. The project aimed to improve the institutional capacity of the Conservation and Development of City Values Association of İzmir; raise awareness about cultural heritage and cultural heritage protection, and, to create a sustainable network among the related stakeholders.

- The Association's corporate communication strategy and a three-year road map were prepared through current situation analysis, stakeholder analysis, SWOT analysis and workshops.
- A Digital Management System consisting of three modules focusing on human resources management, communication and accounting was created for the improvement of the institutional capacity of the Association.
- With the participation of 349 people in total, training was given on 14 different subjects in the field of cultural heritage.
- Within the scope of the training activities organised to enhance the capacities of CSOs, 178 people were trained on 10 different topics such as project cycle management, resource development, volunteer management, strategic thinking, press and media management, monitoring and evaluation, etc.
- A web-based network/platform was created to increase inter-institutional dialogue and cooperation and a total of 66 institutions, organisations and/or individuals became members of this platform.
- A mobile application was developed in order to facilitate the active citizenship of individuals in the field of cultural heritage protection.
- The centre created within the scope of the project was used by 6 CSOs, 6 individuals and 1 municipality.
- As a result of the workshops organised with the participation of nearly 100 people, a cultural heritage monitoring report was prepared.
- Five field visits organised in the field of cultural heritage contributed to raising the awareness of more than 100 participants.
- Approximately 2.4 million people were reached through the short films produced on three different topics and social media campaigns.



### **PROJECT OBJECTIVES**

The project was carried out so as to bring together CSOs dealing with people with disabilities, the film industry, policy makers and public institutions to identify and collectively address the problems faced by people with disabilities in access to cinema. Within this context, the project was implemented so as to ensure that necessary arrangements were made to improve access to cinema for persons with disabilities; paved the way for dialogue to make the necessary arrangements in the field; and, promoted cooperation and networking among relevant CSOs and professionals of culture and arts.

- 28 good practices from 13 countries were reported and disseminated.
- The content and procedures of the "Accessible Space Certificate" were developed and promoted through workshops.
- To promote the implementation of the "Minimum Quota for Accessible Screening", a promotional video and a guide on good practices were produced and disseminated; stakeholder meetings were organised on the topic, followed by lobbying through meetings with representatives from public institutions and MPs.
- A TV spot was prepared to increase the representation of disabled people in cinema.
- A total of 28 participants from film production companies were interviewed and lobbied about inadequate or inaccurate representation of people with disabilities in the film industry.
- As a result of the surveys conducted with the participation of 32 CSOs and 296 persons with disabilities, a workshop was held to discuss the problems and solutions for equal access to cinema and the results of the workshop were reported.
- The participation of disabled people in Puruli was increased and the number of volunteers in the association was increased to 15.
- 15 "Accessible Culture Platforms" was created with the participation of two representatives from CSOs and the private sector and 2 meetings were held.
- The "Accessible Cultural Activities Web Portal" was published.
- Within the scope of social media campaigns, more than 250,000 interactions were achieved in total.

### **PROJECT OBJECTIVES**

The project was implemented so as to enhance coherence skills in policy-making and build a sustainable cooperation between youth CSOs from Türkiye and Europe. Within this context, it was aimed to improve the institutional and methodological capacities of youth CSOs in order to increase the efficiency of youth work and thereby increase the active and democratic participation of young people in policy making.

- Through the activities organised with the participation of 15 CSOs from Türkiye, Poland and Slovenia, nearly 950 individuals were reached.
- A total of 18 stakeholder meetings were organised in the three countries with the participation of 287 people.
- A total of more than 200 young people were trained in local training activities organised in all three countries.
- The guide for positive examples of Türkiye-EU cooperation and the guide for good practices for youth CSOs were prepared and disseminated together.
- More than 70 people participated in the training activities organised to improve the institutional and organisational capacities of CSOs and their grant and fund management skills.
- The study visit to Slovenia was organised with the participation of 23 people and good practices were observed on site.
- In the international conference organised in Slovenia, which 37 people attended physically and 395 people attended online, the challenges and opportunities in EU-Türkiye cooperation and good practices on improving relations were discussed.
- A guide on opportunities for Turkish youth in EU Member States and European youth in Türkiye was prepared.
